

RESOLUTION # 2012 – 107

RESOLUTION OF THE MAYOR AND COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AUTHORIZING THE SETTLEMENT OF GOVERNMENT RECORDS COUNCIL COMPLAINT NO.: 2010-210 AND THE PAYMENT OF LEGAL FEES IN THE AMOUNT OF \$922.00

WHEREAS, Jesse Wolosky initiated litigation against the Borough of Mount Arlington under GRC Complaint No.: 2010-210 requesting salary information, vendor activity report, an employment contract, resume and a Financial Disclosure Statement for the Municipal Clerk; and


WHEREAS, the Governing Body of the Borough of Mount Arlington received a settlement offer from Jesse Wolosky 's attorney that the litigation would be withdrawn with prejudice if the Borough paid Jesse Wolosky's legal fees in the total amount of \$922.00 (\$135.00 to the current attorney, Walter M. Luers, Esq. and \$787.00 to the initial filing attorney, Jonathan McMeen, Esq.), a copy of which invoices are incorporated herein as if set forth at length; and

WHEREAS, the Governing Body of the Borough of Mount Arlington has decided that the cost to litigate the issue far exceeds the benefits of the results of the litigation.

NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF THE BOROUGH OF MOUNT ARLINGTON, authorizing the settlement of GRC Complaint No.: 2010-210; and the payment of \$922.00, of which \$135.00 shall be made payable to the current attorney, Walter M. Luers, Esq.; and \$787.00 shall be made payable to the initial filing attorney, Jonathan McMeen, Esq.

BE IT FURTHER RESOLVED, THAT, this Resolution shall take effect immediately.
