


**RESOLUTION OF THE MAYOR AND BOROUGH COUNCIL

### HALL RENTAL:

**Banquet Hall Rental Price\* :** \$50/meeting; \$100/month  
**Monitor\*\* :** \$25/meeting; \$50/month  
**TOTAL AMOUNT DUE :** \$75/meeting; \$150/month

\* The Banquet Hall Rental Price is valid for two meetings per month. The meetings will be held on the 2<sup>nd</sup> & 4<sup>th</sup> Wednesday of each month, from 1pm to approximately 3pm.

\*\* The Monitor will open the premises 1 hour prior to the meeting and will close the premises at the conclusion of the meeting. He/she will remain on the lodge premises at all times while the meeting is in session, and will assist the renter if needed.

### CONDITIONS PERTAINING TO USE OF PREMISES:

- Renter agrees that he/she shall not permit the leased space to be occupied by more than 160 persons at any one time.
- Renter shall be solely responsible for any and all damage caused to the premises during his/her use of same, and shall, upon request by Lake Hopatcong Elks, fully indemnify or remit to them the full cost of repairing, correcting or cleaning any damage or deterioration arising as a result of his/her use of the premises.
- Renter shall be responsible for assuring that the premises are used only in a safe and orderly manner and in keeping with any and all applicable local, state and federal rules, regulations and statutes.
- The Renter shall be responsible for the setting up of the hall, and only table decorations will be allowed with absolutely nothing affixed to the ceiling or walls. The contract may include one hour prior to event for setup at the discretion of the management.
- The Renter is responsible for cleaning off the tables upon completion of the event.
- The Renter will pay the agreed amount on a monthly basis
