- A. GERALD KELLY, ESQ. BE APPOINTED AS CHIEF PUBLIC DEFENDER OF THE JOINT COURT OF DOVER, SERVING THE TOWN OF DOVER, TOWNSHIP OF MINE HILL, BOROUGH OF MOUNT ARLINGTON, BOROUGH OF ROCKAWAY, BOROUGH OF WHARTON, AND BOROUGH OF VICTORY GARDENS; AND**
- B. ROBERT CASCONE, ESQ. BE APPOINTED AS PUBLIC DEFENDER OF THE JOINT COURT OF DOVER, SERVING THE TOWN OF DOVER, TOWNSHIP OF MINE HILL, BOROUGH OF MOUNT ARLINGTON, BOROUGH OF ROCKAWAY, BOROUGH OF WHARTON, AND BOROUGH OF VICTORY GARDENS**

**WHEREAS**, the Town of Dover of the County of Morris, State of New Jersey, has established a Joint Municipal Court serving the Town of Dover, Township of Mine Hill, Borough of Mount Arlington, Borough of Rockaway, Borough of Wharton and Borough of Victory Gardens under a Shared Services Agreement with the Town of Dover as the lead agency; and

**WHEREAS**, Gerald Kelly, Esq., be appointed Chief Public Defender of the Joint Court of Dover, serving the Town of Dover, Township of Mine Hill, Borough of Mount Arlington, Borough of Rockaway, Borough of Wharton and Borough of Victory Gardens, at a salary of \$23,031 retainer, for the year 2014 plus \$500 per extra session; and

**WHEREAS**, Robert Cascone, Esq., be appointed Public Defender of the Joint Court of Dover, serving the Town of Dover, Township of Mine Hill, Borough of Mount Arlington, Borough of Rockaway, Borough of Wharton and Borough of Victory Gardens, at a salary of \$23,031 retainer, for the year 2014 plus \$500 per extra session; and



Weisenbeck, Assignment Judge, Superior Court, and to the Honorable Anthony Bucco, State Senator.
