WHEREAS, the Director may also approve the insertion of an item of appropriation for equal amount,



Congratulations! It is with great pleasure that The New Jersey Forest Service informs you that the Borough of Mount Arlington Borough has been awarded a No Net Loss grant in the amount of \$108,600.00.

The purpose of this No Net Loss grant is to provide funding to replace trees lost during deforestation of State lands.
