RESOLUTION OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, APPROVING AND AUTHORIZING THE EXECUTION OF AN INTERLOCAL AGREEMENT WITH THE COUNTY OF MORRIS FOR THE REALIGNMENT OF HOWARD BOULEVARD AT ONEIDA AVENUE PROJECT

WHEREAS, the Borough of Mount Arlington and the County of Morris desire to enter into an interlocal agreement for the realignment of Howard Boulevard at Oneida Avenue Project that will be cost effective for both the Borough and the County, and

WHEREAS, on July 7, 2015 the Borough of Mount Arlington adopted Ordinance No.: 06-15 authorizing and appropriating \$816,404.00 construction costs and \$203,270.00 engineering costs for a total of \$1,019,674.00 for the Realignment of Howard Boulevard at Oneida Project, a copy of which is incorporated herein at length by reference; and

WHEREAS, on February 25, 2016 the Borough Engineer presented a revised cost estimate for the project entitled "Project Scope and Cost Summary", a copy of which is incorporated herein at length by reference, detailing \$748,230.75 construction costs and \$278,093.00 contingency and engineering costs for a total of \$1,026,324. This cost estimate shall be incorporated into the interlocal agreement; and will require that Ordinance No.: 06-15 be revised accordingly; and

WHEREAS, the Borough of Mount Arlington, the Borough Attorney, and the Borough Engineer reviewed and approved the interlocal agreement entitled "An Agreement by and between the Borough of Mount Arlington and the County of Morris, providing for the Authorization of a Project Entitled, "Realignment of Howard Boulevard at Oneida Drive", a copy of which is incorporated herein at length by reference; and recommends that agreement be executed; and a revised Ordinance be introduced.

NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF THE BOROUGH OF MOUNT ARLINGTON, THAT the interlocal agreement for the realignment of Howard Boulevard at Oneida Avenue Project is approved; and the Mayor and Borough Clerk are authorized to execute same; and

BE IT FURTHER RESOLVED, THAT Ordinance No.: 06-15 be revised.
