**A RESOLUTION OF THE MAYOR AND BOROUGH COUNCIL OF THE

NEW JERSEY, AUTHORIZING RELEASE OF PAYMENT AND PERFORMANCE  
BONDS FOR THE 2016 ROAD RESTORATION PROJECT**

**WHEREAS**, the Borough of Mount Arlington entered into a Contract with Intercounty Paving Associates, LLC in connection with the 2016 Road Restoration Project; and

**WHEREAS**, said Contract required that Intercounty Paving Associates, LLC deliver to the Borough a Payment and Performance Bond pursuant to N.J.S.A. 40:55D-53 in the total amount of \$522,969.30 to guarantee the proper completion of the projects; and

**WHEREAS**, the Borough Engineer's has received the Maintenance Bond for the completed project and has recommended release of the Payment and Performance Bonds.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, State of New Jersey, that the Payment and Performance Bonds in the amount of \$522,969.30 be hereby released to Intercounty Paving Associates, LLC.

This Resolution shall take effect immediately.
