
**RESOLUTION OF THE MAYOR AND BOROUGH COUNCIL

For the calendar year of 2010 the fees for the impoundment & confinement for cats in our facility will be as follows:

Monthly retainer fee	\$150.00
Maintenance fee per day/adult cats and self-sufficient kitten	\$18.00 per day
Kittens 0-7 weeks (brought in with a mother) all will be held until kittens are weaned	\$19.00 for all
Kittens 0-7 weeks (brought in without a mother)	\$17.00 per kitten

Township may remove these kittens after the 7-day period to a foster home or continue to pay weekly until the doctor determines they are healthy as well as self sufficient enough to be adopted out.

Euthanasia \$34.00

Cremation \$34.00

Any DOA animals left in kennel instead of being properly disposed of into the crematory freezer will be subject to an additional fee of \$116.00 to cover expenses & inconvenience of staff in the removal & sanitizing process.

Decapitations: 1-20 lb \$140.00	21-50 lb \$175.00	51-100 + \$250.00
Quarantine Fees: Cat / \$32.00 per day		

For any cat brought into the facility with fleas & / or ticks there will be an additional charge of \$9.00 for their treatment.

NOTE: Any ACO that trips the alarm which requires the police to dispatch must pay the police fee plus staff fee of \$27.00 for an after hours inspection.

- 1) When the seven day impoundment period are up for moms and kittens the townships must continue to pay the daily boarding fees for them until the townships can remove the mom and kittens to foster homes.
- 2) False alarms will be paid for by the township whose ACO committed the violation.
- 3) As per our May 13, 2009 letter we no longer accept nursing kittens without mothers.
