RESOLUTION OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, NEW JERSEY, AUTHORIZING TEMPORARY SUSPENSION OF PARKING RESTRICTIONS ON SEASONS DRIVE, AS SET FORTH IN CHAPTER 169, SECTION 37 OF THE CODE OF THE BOROUGH OF MOUNT ARLINGTON

WHEREAS, A&R Midstate Management is scheduled to have road repairs performed on Maple Lane and Sycamore Way during the month of September, 2010; and

WHEREAS, the aforementioned improvements will periodically disrupt access to certain properties and driveways along Maple Lane and Sycamore Way; and

WHEREAS, in an effort to lessen the hardship and disruption to the residents of Seasons Glen, parking restrictions on Seasons Drive in accordance with the Borough's Traffic Code, Chapter 169, shall be temporarily suspended.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, State of New Jersey, that beginning on or about September 7, 2010 and ending on or about September 30, 2010, parking of vehicles shall be permitted on Seasons Drive. The temporary amendment shall not permit or otherwise authorize anyone to park a vehicle in an unsafe manner or in a manner that disrupts the safe flow of vehicular or pedestrian traffic. The members of the Mount Arlington Police Department have the authority to remove any vehicle found parked in an unsafe manner or in a manner that disrupts the safe flow of vehicular or pedestrian traffic at the expense of the vehicle owner or operator.

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to the Chief of Police and A&R Midstate Management.

This Resolution shall take effect immediately.
