RESOLUTION OF THE BOROUGH OF MOUNT ARLINGTON RECOMMENDING:

- A. MANUEL FANARJIAN, ESQ. BE APPOINTED AS CHIEF PROSECUTOR OF THE JOINT COURT OF DOVER, SERVING THE TOWN OF DOVER, TOWNSHIP OF MINE HILL, BOROUGH OF MOUNT ARLINGTON, BOROUGH OF ROCKAWAY, AND BOROUGH OF WHARTON; AND
- B. DOUGLAS CABANA, ESQ. BE APPOINTED AS PROSECUTOR OF THE JOINT COURT OF DOVER, SERVING THE TOWN OF DOVER, TOWNSHIP OF MINE HILL, BOROUGH OF MOUNT ARLINGTON, BOROUGH OF ROCKAWAY, AND BOROUGH OF WHARTON

WHEREAS, the Borough of Mount Arlington of the County of Morris, State of New Jersey, is in the process of establishing a Joint Municipal Court serving the Town of Dover, Township of Mine Hill, Borough of Mount Arlington, Borough of Rockaway, and Borough of Wharton under a Shared Services Agreement with the Town of Dover as lead agency; and

WHEREAS, Manuel Fanarjian, Esq. has heretofore served as Prosecutor of the Municipal Courts of the Town of Dover and Borough of Rockaway; and Douglas Cabana, Esq. has heretofore served as Prosecutor of the Municipal Courts of the Township of Mine Hill, Borough of Mount Arlington, and Borough of Wharton;


NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Mount Arlington, State of New Jersey, at its regular meeting of January 19, 2010, hereby recommend that Manuel Fanarjian, Esq. be appointed Chief Prosecutor and Douglas Cabana, Esq. be appointed Prosecutor of the Joint Municipal Court serving the Town of Dover, Township of Mine Hill, Borough of Mount Arlington, Borough of Rockaway, and Borough of Wharton; and
