WHEREAS, the Borough of Mount Arlington of the County of Morris, State of New Jersey, is in the process of establishing a Joint Municipal Court serving the Town of Dover, Township of Mine Hill, Borough of Mount Arlington, Borough of Rockaway, and Borough of Wharton under a Shared Services Agreement with the Town of Dover as lead agency; and

WHEREAS, Timothy Downs, Esq. has heretofore served as Public Defender of the Municipal Court of the Town of Dover; and Gerald Kelly, Esq. has heretofore served as Public Defender of the Municipal Court of the Borough of Rockaway;


