NEW JERSEY, AUTHORIZING THE BOROUGH TO ENTER INTO AN AGREEMENT WITH THE BOROUGH OF WHARTON

FOR PROVIDING STREET SWEEPING OF VARIOUS ROADS

AND CLEANING OF CATCH BASINS WITHIN THE BOROUGH OF MOUNT ARLINGTON

WHEREAS, the Borough of Wharton has received a request from the Borough of Mount

Arlington for providing street sweeping of various roads and cleaning of catch basins within the

Borough of Mount Arlington; and

WHEREAS, the length of this agreement shall be effective on the date of execution

through December 31, 2010.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the

Borough of Mount Arlington that the aforesaid Agreement with the terms set forth in the

attached Agreement be accepted and that the Mayor and Borough Clerk are hereby authorized to

execute said agreements.

AN INTERLOCAL SERVICES AGREEMENT BETWEEN THE BOROUGH OF WHARTON AND THE BOROUGH OF MOUNT ARLINGTON FOR THE PURPOSE OF STREET SWEEPING OF VARIOUS ROADS AND CLEANING OF CATCH BASINS WITHIN THE BOROUGH OF MOUNT ARLINGTON

THIS AGREEMENT, made this 20 day of John 2010 between the BOROUGH OF MOUNT ARLINGTON, hereinafter referred to as the "BOROUGH" and the BOROUGH OF WHARTON, hereinafter referred to as the "SERVICE PROVIDER".

WHEREAS, pursuant to Interlocal Services Act, N.J.S.A. 40:8A-1 et seq., local units may join together to provide authorized services for each other; and

WHEREAS, the SERVICE PROVIDER and the BOROUGH desire to join together in an agreement whereby the SERVICE PROVIDER will perform on behalf of the BOROUGH the sweeping of various roads and catch basin cleaning within the BOROUGH; and

WHEREAS, this agreement must be authorized by a Resolution adopted by the Mayor and Council of the BOROUGH, and a Resolution adopted by the Mayor and Council of the SERVICE PROVIDER; and

WHEREAS, the necessary resolutions have been adopted prior to the execution of this agreement:

WITNESSETH, that the SERVICE PROVIDER hereby agrees as follows:

A. To perform street sweeping and catch basin cleaning as directed by the BOROUGH for roads located within the BOROUGH and will furnish a street sweeper and one operator to perform same.

- 1. The rates noted below will apply when SERVICE PROVIDER employees and equipment are utilized in the street sweeping activities and catch basin cleaning operations. The BOROUGH agrees to reimburse the SERVICE PROVIDER at the following rate:
 - a. Street Sweeper with Operator \$85.00 per hour
- 2. Payment shall be made monthly upon receipt from the SERVICE PROVIDER of a properly executed BOROUGH voucher.
- 3. Time charged for services will include travel time to and from the assigned task and vehicle cleaning as a result of the services rendered.
 - 4. The BOROUGH will provide the following:
 - a. Suitable location for dumping street sweeping materials
 - b. Water supply for the street sweeper as needed
 - c. Additional labor as necessary for the catch basin cleaning

This Agreement shall be effective on the date of execution and shall be for the calendar year commencing as of the execution of this agreement through December 31, 2010.

The SERVICE PROVIDER reserves the right to renegotiate this Agreement at any time during the life of the Agreement for the purpose of rate schedule modifications. If the parties are unable to reach a satisfactory agreement as to a renegotiated rate schedule, the SERVICE PROVIDER reserves the right to terminate this Agreement upon fifteen (15) calendar days written notice to the BOROUGH.

The BOROUGH hereby agrees to pay for all services rendered to the date of termination and the SERVICE PROVIDER hereby agrees not to terminate services until the expiration of the fifteen (15) calendar days written notice time period.

IN WITNESS WHEREOF, the parties hereto have caused these presents to be signed by their duly authorized proper officers and their proper seals affixed hereto all on the day and year first above written.
