- 5. The surplus property as identified shall be sold in an "as-is" condition without express or implied warranties.
- 6. The successful bidder(s) shall be required to pay the full amount of the sale, execute a hold harmless and indemnification agreement in favor of the Borough of Mount Arlington and shall be required to make arrangements for the pick up of said property from the Borough of Mount Arlington within 10 days of the auction.
