

**RESOLUTION OF THE BOROUGH OF MOUNT ARLINGTON,
COUNTY OF MORRIS, STATE OF NEW JERSEY,
AUTHORIZING DISPOSAL OF VEHICLES NO LONGER NEEDED
BY THE BOROUGH OF MOUNT ARLINGTON
THROUGH GOVDEALS AUCTION**

WHEREAS, the Borough of Mount Arlington is the owner of certain vehicles which are no longer needed for public use; and

WHEREAS, the Mayor and Council are desirous of auctioning said vehicles in an "as is" condition without express or implied warranties.

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Mount Arlington as follows:

1. The sale of the vehicles shall be conducted through GovDeals pursuant to State Contract A-70967/T2581 in accordance with the terms and conditions of the State Contract. The terms and conditions of the agreement entered into with GovDeals is available online at www.govdeals.com and also available from the Deputy Municipal Clerk of the Borough of Mount Arlington.

2. The sale will be conducted online and the address of the auction site is www.govdeals.com.

3. The sale is being conducted pursuant to N.J.S.A. 40A:11-36 and NJ Department of Community Affairs, Local Finance Notice 2008-9.

4. A list of the vehicles to be sold is as follows:

a. 1987 4x4 Mack single axel dump truck with 39,739 miles, VIN # 1M2s137CXHA001469. (included therewith is a 5-7 yard stainless steel spreader Hi-Way Model- 500 and Gled Hill power angle 11 ft snow plow).

b. 2000 Ford Crown Victoria Police Interceptor, 4.6 liter V-8 with 97,152 miles, VIN # 2FAFP71W12X131806.


5. The vehicles as identified, including any attachments or included items, shall be sold in an "as-is" condition without express or implied warranties.

6. The successful bidder(s) shall be required to pay the full amount of the sale, execute a hold harmless and indemnification agreement in favor of the Borough of Mount Arlington and shall be required to make arrangements for the pick up of said vehicles from the Borough of Mount Arlington within 10 days of the auction.

7. The Mayor and Council reserve the right to accept or reject any bid submitted.

8. The Business Administrator and Deputy Municipal Clerk are hereby authorized and directed to take such ministerial actions as are necessary to effectuate this resolution including but not limited to the publishing of the required notice of auction per N.J.S.A. 40A:11-36(3).
