A RESOLUTION OF THE MAYOR AND COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY TO EXCEED 5% OF PREVIOUS YEARS LEVY

(Amending Resolution 2010-81)

Whereas, due to the late adoption of the Borough of Mount Arlington's 2010 Municipal Budget and 2010 Morris County Budget, the Morris County Board of Taxation is unable to certify tax rates for the year 2010, and

Whereas, without a 2010 certified tax rate the Tax Collector of the Borough of Mount Arlington will be unable to issue 2010 final tax bills on a timely basis;

Whereas, in accordance with Chapter 72, P.L. 1994, the Mayor & Council of the Borough of Mount Arlington requests the Director of the Division of Local Government Services to approve the 2010 estimated tax levy exceeding 105% of the previous year's tax levy. Approval will enable the Borough to meet its financial obligations, maintain the tax collection rate, provide uniformity for tax payments and save the unnecessary cost of interest expenses on borrowing.

Now, Therefore, Be it Resolved by the Mayor & Council of the Borough of Mount Arlington, as follows;

- 1. The Tax Collector of the Borough of Mount Arlington is hereby authorized and directed to prepare and issue estimated tax bills for the Borough of Mount Arlington for the third installment of 2010 taxes. The Tax Collector shall proceed and take such actions as are permitted and required by Chapter 72, Public Laws of 1994 and N.J.S.A. 54:4-66.2 and 54:4-66.3.
- 2. The entire estimated tax levy for 2010 is hereby set at \$16,516,865.12. The estimated tax rate for 2010 is hereby set at 2.406.
