RESOLUTION OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AUTHORIZING THE ACCEPTING OF PROPERTY AND RECORDATION OF THE PROPOSED DEED OF ROADWAY DEDICATION FOR THE AREA TO BE CONVEYED TO THE BOROUGH LOCATED ON BLOCK 26, LOT 4, DUNLAP STREET, FOR A PROPOSED RIGHT OF WAY

WHEREAS, Our Lady of the Lake R.C. Church desires to convey a certain tract or parcel of land and premises situated in the Borough of Mount Arlington located on Block 26, Lot 4, to the Borough of Mount Arlington; and

WHEREAS, the Borough of Mount Arlington Borough Engineer, Suburban Consulting Engineers, Inc., prepared a Proposed Right of Way Acquisition Plan and a Metes and Bounds Description of Right of Way, dated November 29, 2010, for the Dunlap Street project, located on Block 26, Lot 4, a copy of which is incorporated herein at length by reference; and


WHEREAS, in order to effectuate the acceptance of the property, the proposed Deed of Roadway Dedication for the Proposed Right of Way Acquisition Plan and a Metes and Bounds Description of Right of Way, dated November 29, 2010, for the Dunlap Street project, located on Block 26, Lot 4, is required to be recorded in the Morris County Clerk's Office; and

WHEREAS, the Borough of Mount Arlington Borough Attorney and the Borough Engineer have reviewed and approved the Deed of Roadway Dedication; and

WHEREAS, the Mayor and Borough Council of the Borough of Mount Arlington reviewed the Deed of Roadway Dedication; and a Proposed Right of Way Acquisition Plan and a Metes and Bounds Description of Right of Way, dated November 29, 2010, a copy of each of which is incorporated herein at length by reference; and recommends that the Deed of Roadway Dedication be recorded in the office of the Morris County Clerk.

NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF THE BOROUGH OF MOUNT ARLINGTON, THAT the Deed of Roadway Dedication; and a Proposed Right of Way Acquisition Plan and a Metes and Bounds Description of Right of Way, dated November 29, 2010, shall be recorded in the office of the Morris County Clerk.
