

**BOROUGH OF MOUNT ARLINGTON  
COUNCIL MEETING MINUTES  
DECEMBER 14, 2010**

**1. Call to Order**

- 2. Adequate notice** of this meeting of the Mayor and Borough Council of the Borough of Mount Arlington was given as required by the Open Public Meetings Act as follows: Notice was published in the Roxbury Register and the Daily Record on November 25, 2009; notice was posted on the bulletin board in the main hallway of the Municipal Building on November 23, 2009 and has been available to the public; notice of this meeting is on file in the office of the Borough Clerk.

In accordance with the Open Public Meetings Act (N.J.S.A. 10:4-1 et seq.), the Borough Council opens every public meeting for comments of the public. However, in accordance with N.J.S.A. 10:4-12 : "Nothing in this Act shall be construed to limit the discretion of a public body to permit, prohibit or regulate the active participation at any meeting,...."

Speakers at Borough meetings shall have five minutes to present their comments to the Borough Council so as not to consume time that would otherwise be allotted to other persons who wish to speak. Speakers shall be courteous to the Council and other persons attending the meeting. Offensive remarks or unruly behavior will not be allowed and anyone who violates this policy will be barred from participating in the meeting.

**3. Flag Salute**

The Mayor asked for a moment of silence to remember our armed forces fighting for our freedom.

**4. Roll Call**

Dave Monahan, Mount Arlington Public School, showed a video of the activities leading up to and the actual Veterans Day Ceremony held at the school.

**1. Energy Efficiency Discussion:**

The Mayor stated the Borough is contemplating purchasing our energy from a third party at a reduced rate.

- Robert Shagnon, Glacial Energy, gave a presentation and distributed a price comparison with JCP&L's rates. Glacial can save the Borough about 15% on their current metered energy charges for the next twelve months; they purchase directly from the grid.
- Tony Menchaca, Verde Energy USA, gave a presentation, indicating Verde serves both commercial and residential accounts. Mr. Menchaca distributed a handout which included one price for the Borough and a lower price if the Borough and schools join together; they charge a monthly variable rate and as the account gets larger, they offer a twelve-month fixed rate; the best percentage savings would be 20%, least savings would be 10%.

**8. Open to Public**

The Mayor stated the ordinance has been in our Code for quite some time but has not been fully enforced. Recently, the Borough has been aggressively enforcing this ordinance because of the improvements in the infrastructure, trying to increase property values, and trying to attract businesses and grow our community. Many of the residents in the audience expressed by raised hands that they were attending the meeting due to the issuance of recent violations and some expressed the problems of costs incurred by moving/storing their items. Councilman Doran stated this was enforced late in the season so for boat owners and suggested the Council be open to making some extensions. The Mayor stated the Zoning Committee will be working on revising this ordinance, possibly by February/March. The Mayor stated one alternative may be the redevelopment of the landfill for storage and long term parking, possibly offering residents a discount rate. Council agreed to strict enforcement of the front yard violations, anything that encroaches on the streets or right of ways, and safety and health issues but otherwise will grant a full relaxation of this ordinance until May 15, 2011; the ordinance will be enforced at its fullest at the beginning of boating season next year.

- Ms. Maler appreciates all the holiday lights but she would also like a Hanukkah light. Council President Galate stated a recent Supreme Court decision states in order to have a Hanukkah light, we must also have a crèche; a Christmas tree is secular, not religious.

Marlene Ackerman, 56 Rogerene Way:

- Ms. Ackerman asked about the number of electric bills the borough receives; the Mayor stated we are billed by meter, about 28 bills.

## 10. Old Business

1. Snow Removal, Ordinance #20-09, adopted August 3, 2009.

The Mayor stated the Borough was clearing the snow on certain sidewalks where residents had a hard time accessing those sidewalks; the ordinance was revisited because our previous attorney was concerned about the liability issue. The Clerk read an email into the record from Matthew Giacobbe, Esq., dated November 21, 2010: "It has been determined that the sidewalks are within the right-of-way of the roadways. I suggest we go back to the way we were handling it with our DPW or contractor clearing the sidewalks we used to clear. We will need to discuss this after December 14, 2010." There is no liability issue, we have the right to be there clearing those sidewalks. Council will revisit the existing ordinance in February/March.

2. Council Comments.

Councilman Sorge:

- Stated the Veteran's Day Ceremony went very well.
- Thanked the Fire Department for their response to recent fire at the Shore Hills Apartments; there are fire volunteers on our DPW which is key to quick responses within the Borough.

Councilman Doran:

- The DEP has issued a press release on the publication of the Lake Level Management Report; the Lake Hopatcong Commission will be holding hearings on this report sometime in January.
- Looking into automatic bill payment to reduce window traffic for the payment of taxes and utilities. The computer package would give email alerts to customers prior to a payment/debit being withdrawn. Patricia Simari, Tax Collector, is researching the different programs.
- Water and Sewer Committee met and discussed the fire hydrant maintenance between Mount Arlington and Roxbury. At the last Council meeting, the Borough approved payment to Roxbury of \$21,000 to settle an eleven year dispute over fire hydrants; meanwhile, our engineering firm researched the fire hydrants and found Roxbury fire hydrants that Mount Arlington is maintaining. This is a work in process as we may have a counterclaim with Roxbury.

The sewer and water fees being charged to Mount Arlington customers only will require continued adjustment upward in order to get our sewer and water companies self-sufficient. We will notify all of our customers that we will start increasing these rates this year to reflect an increase of about 12.5% for both water and sewer, and will continue this increase for a three year period. We need to do this to live within the terms of the Memorandum of Understanding and in order to live within the 2% cap; the increase will be effective first quarter of 2011. The Clerk will provide an ordinance at the January 4, 2011 meeting, incorporating the increase in fees. Councilman Sadow asked if the Borough could sell this authority to possibly save money and run more efficiently. Councilman Doran stated if we sold and decreased the manpower of DPW. The Borough could not perform all the other duties DPW performs. The Mayor stated water companies are more interested in purchasing systems with wells, whereas the Borough is just a pass through without our own wells. The Mayor stated it is very costly to perform a study to price everything out for both water and sewer. Councilman Sadow stated he would like to revisit this issue.

Councilwoman Galate:

- Recently came across the Blest Machine, a new machine that converts plastic to fuel; which could be a source of revenue for the Borough not only to recycle for fuel, but sell the fuel. The machine converts 2.2 lbs. of plastic into 1 quart of oil.
- There was an article in the League of Municipalities magazine about having a community garden and how it increased the property values 9.4%.
- Congratulated the Mayor on being elected First Vice President of the League of Municipalities and President of the League's Educational Foundation.

Councilman Windish:

- Recreation is looking into more adult programs and will confirm insurance/liability issues with the Finance Department. They are looking to redevelop the roller rink area, possibly for volleyball courts and/or tennis courts; the present tennis courts are in condition and in need of repair and maybe the Borough can use that site for the community garden.

Mayor thanked Councilman Driscoll for his many years of service as Council Member and expressed his appreciation for his work over the years, including saving the Borough so much money working with our IT systems. Councilman Driscoll received a round of applause from both Council and the audience.
