The Mayor explained that the current Open Space Tax benefits all in Morris County and an additional Borough tax would be another burden to taxpayers; he wanted to confirm that those who signed the petition understood all the facts. Attorney Bell explained the various forms of referendum, citing Election Law 19:37-1 and 19:37-2.

Paula Danchuk, 50 Elizabeth Way:

- Ms. Danchuk furthered the conversation regarding an additional Open Space Tax referendum on the November ballot. Council advised that they will read and digest the petition and possibly discuss this issue at the next meeting.
- Ms. Danchuk again asked Council to consider Judge Bonzonelis' decision and instructions in the case of Lake Rogerene Association vs. the Land Use Board and gave a written request of items she would like included in the March 12, 2007 Minutes to the Clerk. Council requested Ms. Danchuk provide a full copy of the Bonzonelis' decision to the Clerk.

Robin Anderson, 54 Rogerene Way:

- Ms. Anderson stated that there are more (Open Space Tax) petitions/surveys being circulated and other signatures are forthcoming.
- Ms. Anderson had reviewed the Lake Rogerene roadway construction plans and has spoken with Daren Phil, who indicated that the project would be about 3 weeks on site.





We the undersigned residents of the Borough of Mount Arlington urge Mayor Arthur Ondish and members of the Town Council to initiate the application process to secure grant money for the purchase of vacant land. This grant money is available from the Morris County Open Space Preservation Fund. We understand that since the inception of the Morris County Open Space Trust Fund on July 1, 1993, Mount Arlington taxpayers have contributed approximately \$1,731,000.00 to this fund and that the governing body of Mount Arlington has not submitted a single request for any portion of these Funds to preserve open space in Mount Arlington. These tracts of land are among the last large contiguous parcels of undeveloped property available in the Borough of Mount Arlington and face an immediate threat of development. These parcels lie in areas of environmental significance and contain upland habitat adjacent to Lake Rogerene including the bulk of the undisturbed area necessary to the recharge of Lake Rogerene. These parcels include Block and Lot, 86-5, 87-7, 88-1, 89-16, 89-22, 90-13, 93-1, 94-1 and 94-13. With the exception of 93-1 and 94-1, these parcels are connected, totaling approximately 15 acres, and adjoin a large section of protected land lying in Roxbury Township. Block 93-1 and 94-1 are separate and contain the outflow creek from Lake Rogerene.

open space. Not long ago, Mount Arlington had the most open space preserved land for a town our size, than any other in Morris County. Not too many years ago, Morris County put in place an open space tax that is included in the county portion of your tax bill. This money goes into a fund that is used to preserve open space. I volunteered to sit on the Morris County Open Space Committee last year and got quite education. It is a two-year term and I plan to learn as much as I can this year. I intend to use that knowledge to save any and all undeveloped land left in town where possible.

I would like to have the town council meeting minutes of March 12, 2007 amended to included my statements made regarding the Shadow Woods Developer's agreement. Because the discussion of the developer's agreement for Shadow Woods and Valley Road was moved to executive session, I asked the council to please refer to and keep in mind Judge Bozonelis' decision in the case of LRCA v. Land Use Board ... Docket No. MRS-L-869-06.

I would also like the Mach 12, 2007 minutes to note that several council members appeared to act as if they had no previous knowledge of the ramifications of the judge's decision and asked to see the decision. The township attorney stated that she had a copy of the decision and would be able to show it to them before the discussion on the developer's agreement took place.

At tonight's meeting, I would just like to mention that after reading the Shadow Woods developer's agreement signed on March 13, 2007, there is no mention of Orben Drive with reference to the anticipated construction traffic and no quantification of the impact to be anticipated by the residents of Lake Rogerene.

Once again I refer to the case of LRCA v. Land Use Board ... Docket No. MRS-L-869-06. Judge Bozonelis decided against any action. His conclusion was that if the Board and the Town determined that the Orben Drive roadway was sufficient, it was. Implicit in this view is that the Borough, as the ultimate responsible authority, could arrive at that conclusion, and if incorrect would bear the consequences and be responsible to the residents for any injury or loss of quality of life because of their oversight. Judge Bozonelis also mentioned at during the trial that the question of Orben Drive, it's safety, and the quantification of truck traffic during construction, and the possible repair, rebuilding or replacement of Orben would await the Developer's Agreement.

I am asking for the council's assurance that this is just a beginning developer's agreement with Shadow Woods and that an agreement will be put into place which addresses all the concerns of Lake Rogerene residents.
