

**BOROUGH OF MOUNT ARLINGTON
COUNCIL MEETING MINUTES
JUNE 12, 2006**

1. Call to Order

- 2. Adequate notice** of this meeting of the Mayor and Borough Council of the Borough of Mount Arlington was given as required by the Open Public Meetings Act as follows: Notice was published in the Roxbury Register and the Daily Record on January 19, 2006; notice was posted on the bulletin board in the main hallway of the Municipal Building on January 10, 2006 and has been available to the public; notice of this meeting is on file in the office of the Borough Clerk.

3. Flag Salute

The Mayor asked for a moment of silence to remember our troops serving us, all the military helping to allow us the ability to have these open public meetings.

4. Roll Call

Councilwoman Mulligan, Councilman Doran, Councilman Sorge, Councilwoman Cerasoli, Council President Driscoll, Councilman Stone, Mayor Ondish. JoAnne Sendler, Borough Administrator, and Nancy Gage, Borough Attorney, were also present.

5. Presentations/Mayor's Appointments

McFlowertown Award.

The Mayor stated that we received the McFlowertown Award from Morris Tomorrow; they give annual awards for different improvement categories within a municipality. We submitted the improvements at Memorial Park and were judged with three other towns. The official plaque was displayed at the Council meeting and will be mounted in the Park. The Mayor read the Certificate of Award into the record.

Mark Rinaldi, Beach Bash Coordinator Appointment.

The Mayor stated that he is appointing Mark Rinaldi as Beach Bash Coordinator and asked for Council concurrence; all approved.

Margarette Wilson, Land Use Board Member, Alternate IV (filling unexpired 2-year term, expires 12/31/06)

Due to the fact that Mayor Ondish did not personally announce this appointment at the February 13, 2006 Council Meeting, he reiterated the previously announced appointment.

Scott Levitt, Land Use Board Member, Class IV, Appointment Rescinded, effective June 12, 2006.

The Mayor rescinded Scott Levitt's Land Use Board appointment and asked for Council concurrence; all approved.

The Mayor does have a resident of Ridgeview to fill this position and will make the appointment at the next Council meeting.

1. Medical Reserve Corp. mailing – OEM/Health Department.

JoAnne Sendler stated that we have a letter going out tomorrow over the Mayor's signature to all residents, asking whether or not they have a medical background and would be willing to help in case of a medical emergency. The County OEM is suggesting we send this letter, which will be handled by our OEM and Board of Health. The person's licensing information is included on the forms so background checks will not have to be done.

2. Clerk's Follow-Up Report Memorandum, dated June 8, 2006.

The Clerk discussed the items on the follow-up list, noting further follow-up direction/status of any open items.

Councilman Doran asked if there was a new date for the removal of the MacDowell porch; Nancy Gage stated that in the agreement we allotted three months from the time of signing. JoAnne Sendler stated the agreement indicates total completion of six months.

11. Open to Public

Charles Squires, 26 Birch Terrace:

- Mr. Squires congratulated the incumbents on their recent victory at the Primary Election.
- Mr. Squires, as member of Senior Citizen Club, made application to the State for a Bingo license, playing twice a week with 3 games for \$1, just within the members. Mr. Squires submitted the application to the licensing bureau in April and recently sent a letter, copying Senator Bucco, inquiring the status. Linda DeSantis has been involved and spoke to Legalized Games today; they acknowledged receipt of the letter but the license has not been issued as of yet.
- Mr. Squires stated he was disappointed with the rescinding of Scott Levitt from the Land Use Board; seems to him that since Mr. Levitt was involved in the recent Primary, this was poor timing. The Mayor stated the election had nothing to do with it as Mr. Levitt was going to be removed prior to the election.

Gary Keifer, 2 Dunlap Street:

- Mr. Keifer had previously inquired about getting water on Dunlap Street and wanted to know the status. The Mayor stated he would speak to Daren Phil. The Mayor stated that we have an allocation problem with the MUA; we are reaching our limit so we are doing only emergency hook-ups. Mr. Keifer stated it would include only two homes on Dunlap and one on Park, and maybe the old Catholic School. JoAnne Sendler stated that this also depends on the cost of the pipes; the builders pay for the pipes in the new developments. The Mayor stated that the water is a separate entity and none of the tax dollars go toward water.

Dick Husni, 30 Mountainview Avenue:

- Mr. Husni thanked Council for putting up the fence and wanted the status of landscaping and grading on his side of the fence. The three other houses also had work done behind them and they were supposed to have a wooden fence. The Mayor stated there was never talk of a wooden fence but rather shrubbery. The Mayor confirmed that the fence was installed as promised. Mr. Husni stated that the fence did not go in front of the salt shed.
- Mr. Husni noted a survey marker halfway down Altenbrand. The Mayor stated that it probably has to do with the Streetscape Project. Mr. Husni stated that the road is already 15 feet to the right but he prefers the road stay centered. The Mayor stated that Daren Phil had asked for a survey so he can determine where the Borough property lines are.

Jeff Sansone, 24 Mountainview Avenue:

- Mr. Sansone asked who is responsible for keeping the municipal beach and swimming area clean; the Mayor stated DPW. Mr. Sansone stated that it is unswimmable due to the weeds. The Mayor stated that DPW is not responsible for the weeds, the lifeguards are supposed to rake the weeds. The Mayor stated that this is the worst season for weeds in years and the lifeguards will do the best they can. The Mayor stated we would refresh the memories of the lifeguards regarding their responsibilities.
- Mr. Sansone stated that he lives next door to Mr. Husni and the new fence that was erected behind Mr. Husni's house stops at his property line, leaving the salt shed fully exposed and the noise has become considerably louder. Mr. Sansone saw where fence was going to go but the plan was altered; can the fence be extended because now it is an unfinished job. The Mayor stated he will look into this.

The Mayor opened the Hearing to the Public on Ordinance #16-06 and read the Ordinance by title.

Richard Husni, 30 Mountainview Avenue, stated that a lot of the rates have gone up considerably. The Mayor stated this was to mimic the UCC Code and be consistent to what other towns are charging. JoAnne Sendler stated that we are going to do other ordinances that will eliminate fees. The Mayor stated that we are updating the Land Use Ordinances which have not been updated in a long time and we will be eliminating some ordinances that are charging people a lot of money. JoAnne Sendler stated we could postpone adoption and have Sandor Nyari attend the next Council meeting; the Mayor agreed.

Jeff Sansone, 24 Mountainview Avenue, stated that the laws of economics will prevail, the more you charge, the less people will tell you about and asked if the fees cover the actual costs of the Borough. The Mayor stated some of the fees go to the State, some come back to the Borough, and there is a cost for the inspectors to go out, cost for the paperwork and secretarial work. Ms. Sendler stated it is not a self-sustaining department, we look at an entire budget. The Mayor stated he would like Sandy Nyari to attend the next meeting.

Councilman Stone stated, I move to Table ordinance 16-06 to the next Council meeting.
