RESOLUTION REQUESTING APPROVAL OF THE DIRECTOR OF THE  
DIVISION OF LOCAL GOVERNMENT SERVICES TO ESTABLISH A  
DEDICATION BY RIDER FOR SNOW REMOVAL TO BE  
INCLUDED IN THE 2012 AND SUBSEQUENT BUDGETS

WHEREAS, permission is required of the Director of the Division of Local Government Services for approval as a dedication by rider of revenues received by a municipality when the revenue is not subject to reasonable estimates in advance; and

WHEREAS, P.L. 2001, c.138 permits municipalities to lapse unexpended balances budgeted annually for snow removal or other purposes; and

WHEREAS, N.J.S.A. 40A:4-39 provides that the Director of the Division of Local Government Services may approve expenditures of monies by dedication by rider;

NOW, THEREFORE BE IT RESOLVED by the Mayor and Council, Borough of Mount Arlington, State of New Jersey, that permission be and is hereby requested of the Director of the Division of Local Government Services to include the Dedication by Rider in the 2012 and subsequent budgets, "to pay expenditures for Snow Removal" and dedicated under the provisions of P.L. 2001, c.138, and in accordance with N.J.S.A. 40A:4-39.

BE IT FURTHER RESOLVED that two certified copies of this resolution be forwarded immediately to the Director of the Division of Local Government Services.
