

ORDINANCE # 06 -12

AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER A210 OF THE BOROUGH CODE ENTITLED, "FEES", TO UPDATE THE FEES FOR ANIMAL CONTROL SERVICES PROVIDED IN SECTIONS 48-6 D(2) AND 48-9.1D

WHEREAS, the Council for the Borough of Mount Arlington reviewed and desires to amend the fees set forth in Chapter A210 of the Borough Code, entitled "Fees" to update the fees for Animal Control Services provided in Sections 48-6 D(2) and Section 48-9.1D.

BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, and the State of New Jersey, as follows:

SECTION 1. Chapter A210 of the Borough Code, entitled "Fees", Section §48-6D(2) is hereafter amended and supplemented to read in its entirety as set forth below:

§48-6D(2).

Impoundment fee \$20.00 per day; plus ten dollars \$10.00 for each vaccination and/or medication administered; and \$10.00 for flea and/or tick treatments determined to be necessary.

Pickup of any dog: First Offense \$45.00
Second Offense \$75.00
Third Offense \$100.00

Euthanasia of dog \$35.00

Disposal/Cremation of dog \$35.00

Quarantine of dog \$33.00 Per day

SECTION 2. Chapter A210 of the Borough Code, entitled "Fees", Section §48-9.1D is hereafter amended and supplemented to read in its entirety as set forth below:

§48-9.1D.

Impoundment fee \$20.00 per day; plus ten dollars \$10.00 for each vaccination and/or medication administered; and \$10.00 for flea and/or tick treatments determined to be necessary.

Pickup of any cat: First Offense \$45.00
Second Offense \$75.00
Third Offense \$100.00

Euthanasia of cat \$35.00

Disposal/Cremation of cat \$35.00

Quarantine of cat \$33.00 Per day

SECTION 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistencies.


SECTION 4. If any article, section, subsection, paragraph, phrase, or sentence is for any reason held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed separable.

SECTION 5. This Ordinance shall take effect upon final publication as provided by law.


The following Ordinance was passed on second reading at the Council Meeting of the Borough of Mount Arlington on April 17, 2012.
