AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING BOROUGH CODE CHAPTER 144 SOLID WASTE, ARTICLE I RECYCLING, SECTION §144-2 DEFINITIONS, TO INCLUDE A NEW TERM, BULKY RIGID PLASTIC ITEMS; ARTICLE II COLLECTION, SECTION §144-16 DEFINITIONS, TO INCLUDE A NEW TERM, BULKY RIGID PLASTIC ITEMS; AND SECTION §144-19 PREPARATION FOR COLLECTION AND DISPOSAL TO INCLUDE A NEW SECTION S, BULKY RIGID PLASTIC ITEMS.

WHEREAS, the Mayor and Council of the Borough of Mount Arlington desire to update the Borough's recycling plan so it is consistent with the Morris County Solid Waste Management Plan; and

WHEREAS, the Mayor and Council of the Borough of Mount Arlington reviewed and desire to amend and supplement Borough Code Chapter 144 Solid Waste, Article I Recycling, Section §144-2 Definitions, to add a new term Bulky Rigid Plastic Items; Article II Collection Section §144-16 Definitions, to add a new term Bulky Rigid Plastic Items; and Section §144-19 Preparation for collection and disposal to add a new section S, Bulky Rigid Plastic Items; and

WHEREAS, the Mayor and Council of the Borough of Mount Arlington, by adopting this Resolution, is putting the Borough residents on notice that as of August 1, 2012 all Bulky Rigid Plastic Items may be brought to the Department of Public Works yard on Saturday's only, between the hours of 8:00 a.m. – 1:00 p.m.

BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, and the State of New Jersey, that the Borough Code Chapter 144 Solid Waste, Article I Recycling, Section §144-2 Definitions, is hereby amended and supplemented to add a new term to read as follows:

§144-2. Definitions.

BULKY RIGID PLASTIC ITEMS — shall include, but not be limited to, plastic tables, benches, chairs, riding toys, doll houses, sand boxes, shelving, five (5) gallon pails, car seats and Tyco products.

BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, and the State of New Jersey, that the Borough Code Chapter 144 Solid Waste, Article II Collection Section §144-16 Definitions, is hereby amended and supplemented to add a new term to read as follows:

§144-16. Definitions.

BULKY RIGID PLASTIC ITEMS — shall include, but not be limited to, plastic tables, benches, chairs, riding toys, doll houses, sand boxes, shelving, five (5) gallon pails, car seats and Tyco products.

BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, and the State of New Jersey, that the Borough Code Chapter 144 Solid Waste, Article II Collection,

Section §144-19 Preparation for collection and disposal, is hereby amended and supplemented to add a new section S, Bulky Rigid Plastic Items to read as follows:

§144-19. Preparation for collection and disposal.

S. Bulky Rigid Plastic Items may be brought to the Department of Public Works yard on Saturday's only, between the hours of 8:00 a.m. - 1:00 p.m.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistencies.

SECTION 3. If any article, section, subsection, paragraph, phrase, or sentence is for any reason held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed separable.

SECTION 4. This Ordinance shall take effect upon final publication as provided by law.
