Wilpert explained items listed in report; 409 Howard Blvd; 501 Bensel Dr.; 49A Schmitz Terr.; 105 Schmitz Terr. All information listed in reports is on file in Board of Health Administrators office. F. Wilpert explained items on Nurse's Reports; all information listed in reports is on file in Board of Health Administrators office. Brief discussion regarding two new cases of Lyme disease; possibly holding a Lyme disease seminar for residents. President Tuorinsky inquired about the Legionella Disease listed on the Nurse's Report as this disease resulted in a fatality. F. Wilpert will follow-up tomorrow with the information. President Tuorinsky inquired on how the Health Officer inspects for bedbugs. F. Wilpert explained the visual check done; recommendations are made, usually extermination is suggested; each case is dealt with individually. He also explained that there has been an increase especially in apartment buildings and multi-family dwellings. Member Stanzilis mentioned that all new clothing bought should be washed prior to wearing. She suggested putting information on the Borough Website. Administrator Simari will research that.
