Ordinance Amendment BH2011-01

AN ORDINANCE OF THE BOARD OF HEALTH OF THE BOROUGH OF MOUNT ARLINGTON, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 196 OF THE BOROUGH CODE ENTITLED, "HEALTH SERVICES", TO UPDATE THE FEES FOR HEALTH SERVICES PROVIDED.

President Tuorinsky stated: "The next item on the Agenda for First Reading is Ordinance #BH2011-01 Entitled 'An Ordinance of The Board of Health of The Borough of Mount Arlington, County Of Morris, State Of New Jersey, Amending and Supplementing Chapter 196 of The Borough Code Entitled, "Health Services", To Update the Fees For Health Services Provided'.

Member Puskas stated: "I move that Ordinance #BH2011-01 be introduced by title, and passed on First Reading and that a meeting be held on July 26, 2011 at 7:00pm at the Municipal Building, 419 Howard Blvd., Mt. Arlington, NJ for a Public Hearing, consideration of Second Reading and Passage of said Ordinance, and that the Administrator be directed to publish, post and make available said Ordinance in accordance with the requirements of the law"; seconded by Vice President Westerfield.

Member Puskas inquired as to the increase in fees; F. Wilpert and Admin. Simari explained the increase is to offset the costs to the Borough.

President asked the Administrator to call the Roll.
