The members saluted the flag.

Vice President Tuorinsky made a motion to approve the minutes of March 12, 2013, seconded by Member DiGeronimo.

Review of Health Officer's and Nurse's Reports.

- F. Wilpert went over the Health Officer's report and nurse's report. He informed the Board that he had conducted spot checks on various prior complaints and that all were satisfactory. He went over the complaint regarding mouse droppings at the New Seasons Senior Living facility; two separate inspections were made and the inspectors found no evidence to substantiate the complaint. No further action required.
