WHEREAS, the Borough of Mount Arlington of the County of Morris, State of New Jersey, is in the process of establishing a Joint Municipal Court serving the Town of Dover, Township of Mine Hill, Borough of Mount Arlington, Borough of Rockaway, Borough of Wharton and Borough of Victory Gardens, under a Shared Services Agreement with the Town of Dover as lead agency; and

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Mount Arlington, State of New Jersey, at its regular meeting of January 15, 2013, hereby recommend that Gerald Kelly, Esq. be appointed Chief Public Defender and Robert Cascone, Esq. be appointed Public Defender of the Joint Municipal Court serving the Town of Dover, Township of Mine Hill, Borough of Mount Arlington, Borough of Rockaway, Borough of Wharton and Borough of Victory Gardens; and

BE IT FURTHER RESOLVED that a copy of this Resolution shall be forwarded to the Town of Dover, Township of Mine Hill, Borough of Rockaway, Borough of Wharton and Borough of Victory Gardens, which are hereby being requested to consider adoption of or have adopted a similar Resolution; and

BE IT FURTHER RESOLVED that upon adoption of said resolution by the Town of Dover, Township of Mine Hill, Borough of Mount Arlington, Borough of Rockaway, Borough of Wharton and Borough of Victory Gardens, a copy of said Resolutions shall be forwarded to the Honorable Thomas L. Weisenbeck, Assignment Judge, Superior Court, and to the Honorable Michael Luther, Judge of the Joint Court of Dover.
