
The following Ordinance was passed on second reading at the Council Meeting of the Borough of Mount Arlington on March 4, 2014.

Ordinance #02-14

**AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE
BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, STATE
OF NEW JERSEY, AMENDING AND SUPPLEMENTING BOROUGH CODE CHAPTER 169,
VEHICLES AND TRAFFIC, SECTION 169-13 PARKING PROHIBITED AT ALL TIMES ON
CERTAIN STREETS**

TAKE NOTICE that the above entitled Ordinance was introduced and passed at a regular meeting of the Borough Council of the Borough of Mount Arlington held on February 4, 2014; and after being duly advertised was further considered for final passage at a Council Meeting held on March 4, 2014 at which time, after all persons present were given an opportunity to be heard concerning the same, it was finally passed and adopted and will be in full force in the Borough of Mount Arlington according to law.

AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING BOROUGH CODE CHAPTER 169, VEHICLES AND TRAFFIC, SECTION §169-13 PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS.

WHEREAS, the current Borough Code prohibits parking the entire length of Schmitz Terrace on both sides of the roadway. The Borough Chief of Police inspected Schmitz Terrace and determined that nineteen (19) parking spaces are marked on the western side of the roadway. The Borough Chief of Police found that with vehicles parked in these nineteen (19) marked spaces the roadway remains wide enough for traffic to pass in both directions and these spaces do not create a hazard for the flow of traffic or width of the roadway; and

WHEREAS, the Borough Chief of Police recommends that parking be permitted only in the nineteen (19) marked parking spaces on the western side of the roadway located on Schmitz Terrace; and recommends that the Borough Code be revised; and

WHEREAS, the Mayor and Council for the Borough of Mount Arlington reviewed and desires to amend and supplement Borough Code Chapter 169, Vehicles and Traffic, Section §169-13 Parking Prohibited at all times on Certain Streets to permit parking only in the nineteen (19) marked parking spaces on the western side of the roadway located on Schmitz Terrace.

BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, and the State of New Jersey, that the Borough Code Chapter 169, Vehicles and Traffic, Section §169-13 Parking Prohibited at all times on Certain Streets is hereby amended and supplemented to read in its entirety as follows:

§ 169-13. Parking prohibited at all times on certain streets.

No person shall park a vehicle at any time upon any streets or parts thereof described.

Bertrand Island Road	Both	Between Roxbury Township-Mount

Cove Road	North	Entire length
Cove Road	Both	From its intersection with McGregor Avenue to Lake Hopatcong
Edgemere Avenue	Both	No Parking (Turn around at Dead End)
Harriet Way	Both	From its intersection with Orben Drive to Lake Rogerene
Henry Court	Both	Entire length
Hillside Drive	Both	Entire length
Hopatcong Avenue	Both	West side from its intersection with Edgemere Avenue to Lake Hopatcong
Howard Boulevard (CR 615)	Both	Entire length
Kadel Drive	Both	From the westerly curb line of Howard Boulevard westerly for a distance of 200 feet
Littell Way	Both	Entire length
McGregor Avenue	West	From a point 525 feet southwest of the southerly curb line of James Drive extending 2200 feet southerly
North Dock Lane	Both	From its intersection with North Bertrand Road east to Lake Hopatcong
Oak Path	Both	From its intersection with Orben Drive westerly to Lake Rogerene
Oneida Avenue	Both	From the Roxbury Township-Mount Arlington Borough line east to the westerly curb line of Howard Boulevard
Ridgeview Lane	Both	From Howard Boulevard 300 feet west on Ridgeview Lane
Schmitz Terrace	Both	Entire length of road with the exception of the nineteen (19) marked parking spaces on the western side of the roadway.
South Dock Lane	Both	From its intersection with South Bertrand Road south to Lake Hopatcong
West Dock Lane	Both	From its intersection with West Bertrand Road west to Lake Hopatcong

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistencies.

SECTION 3. If any article, section, subsection, paragraph, phrase, or sentence is for any reason held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed separable.

SECTION 4. This Ordinance shall take effect upon final publication as provided by law.
