AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING BOROUGH CODE CHAPTER 138 SNOW REMOVAL CONTRACTORS, SECTION §138-3 ESTABLISHMENT OF RATES.

WHEREAS, the Borough Department of Public Works Supervisor advised that the Borough Snow Removal Contractor rates need to be amended to reflect industry standards and to delineate specific services in detail; and recommends that the Borough Code be updated; and

WHEREAS, the Mayor and Council for the Borough of Mount Arlington reviewed and desires to amend and supplement Borough Code Chapter 138, Snow Removal Contractors, Section §138-3, Establishment of Rates.

BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, and the State of New Jersey, that the Borough Code 138, Snow Removal Contractors, Section §138-3, Establishment of Rates is hereby amended and supplemented to read in its entirety as follows:

§ 138-3. Establishment of rates.

The rates payable for snow removal and sanding/salting services shall be up to and including the following; and the Borough Department of Public Works Supervisor will determine equivalent classification upon inspection of equipment:

Salt/Grit spreader (Equipment and Operator) \$85.00/hour
Snow removal via motor vehicle with plow \$100.00/hour
Pick-up truck with plow and operator- up to \$115.00/hour
Mason Dump truck or equivalent with plow and operator- up to\$150.00/hour
Single Axle Dump Truck GVWR 34,000 or greater with plow and operator- up to \$180.00/hour
Single Axle Dump Truck GVWR 34,000 or greater with salt spreader- up to \$125.00/hour
Mason dump truck or equivalent with salt spreader- up to \$100.00/hour
Front-End rubber tire loader or back Hoe with 1.5 C.Y bucket or greater- up to \$275.00/hour

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistencies.

SECTION 3. If any article, section, subsection, paragraph, phrase, or sentence is for any reason held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed separable.

SECTION 4. This Ordinance shall take effect upon final publication as provided by law.
