

AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AUTHORIZING THE EXECUTION AND RECORDATION OF THE PROPOSED DEED OF DEDICATION FOR THE DEDICATION OF LOTS AND THE ACQUISITION OF THE REAL PROPERTY LOCATED AT BLOCK NO. 83, LOT NO. 9 AND BLOCK NO. 72.01, LOT NO. 3

WHEREAS, Trailwood Associates, LLC, a New Jersey limited liability company, having an address at 101 Old Short Hills Road, Suite PH-1, West Orange, New Jersey 07052, desires to convey a Deed of Dedication for the Dedication of Lots to the Borough of Mount Arlington in connection with and furtherance of a development project now or formerly commonly known as Shadow Woods for certain tracts or parcels of land situated in the Borough of Mount Arlington located on those certain areas depicted and described as depicted and described as "To be dedicated to the Borough of Mt. Arlington" in Block No. 83, Lot No. 9 and Block No. 72.01, Lot No. 3 (in the Borough of Mt. Arlington, Morris County, New Jersey) as shown on that certain map entitled "Shadow Woods Final Plat," prepared by Omland Engineering Associates, Inc., dated February 28, 2008, and filed in the Morris County Clerk's Office on April 2, 2008 at Map Book 7, Page 50, a copy of which is incorporated herein at length by reference; and, a copy of which is incorporated herein at length by reference; and

WHEREAS, the Borough of Mount Arlington Borough Engineer; the Borough Planning Board Attorney; and the Borough Attorney reviewed the above-referenced conveyance documents, a copy of which is incorporated herein at length by reference; and

WHEREAS, in order to effectuate the acceptance of the property, the proposed conveyance documents and Metes and Bounds Descriptions are required to be recorded in the Morris County Clerk's Office; and

WHEREAS, the Mayor and Borough Council of the Borough of Mount Arlington reviewed the above-referenced conveyance documents and recommends the documents be recorded by the Borough Attorney in the office of the Morris County Clerk.

WHEREAS, the Local Lands and Buildings Law, N.J.S.A. 40A:12-5, authorizes municipalities to acquire real property.

BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, and the State of New Jersey, that pursuant to N.J.S.A. 40A:12-5 the Borough of Mount Arlington is authorized to execute and record the proposed Deed of Dedication for the

Dedication of Lots to the Borough of Mount Arlington in connection with and furtherance of a development project now or formerly commonly known as Shadow Woods for certain tracts or parcels of land situated in the Borough of Mount Arlington located on those certain areas depicted and described as depicted and described as "To be dedicated to the Borough of Mt. Arlington" in Block No. 83, Lot No. 9 and Block No. 72.01, Lot No. 3 (in the Borough of Mt. Arlington, Morris County, New Jersey) as shown on that certain map entitled "Shadow Woods Final Plat," prepared by Omland Engineering Associates, Inc., dated February 28, 2008, and filed in the Morris County Clerk's Office on April 2, 2008 at Map Book 7, Page 50.

BE IT FURTHER ORDAINED, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, and the State of New Jersey, that the recordation of the conveyance documents shall be conducted at a date and time selected by the Borough Administrator upon approval of all documents by the Borough Attorney and the title company. The Borough Administrator and the Borough Attorney shall be authorized and empowered to sign any and all documents required to effectuate the conveyance of this parcel.


SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistencies.


