**RESOLUTION OF THE MAYOR AND BOROUGH COUNCIL
OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF
MORRIS, NEW JERSEY, AUTHORIZING TEMPORARY SUSPENSION
OF PARKING RESTRICTIONS ON SEASONS DRIVE
AS SET FORTH IN NEW JERSEY TRAFFIC CODE 39:4-138**

WHEREAS, A&R Management, on behalf of the Board of Trustees of Seasons Glen, will be embarking on a paving project on Evergreen, Mulberry and Upper Maple, beginning on August 17, 2015, continuing to September 18, 2015; and

WHEREAS, the aforementioned paving project will require additional parking on Seasons Drive (the outer loop of Seasons Drive); and

WHEREAS, in an effort to accommodate this request, parking restrictions on Primrose Lane and Seasons Drive, in accordance with the New Jersey Borough's Traffic Code, 39:4-138, shall be temporarily suspended with the following additional restrictions:

- All winter parking regulations remain in effect.
- No parking within 50' of an intersection.
- No parking within 10' of any fire hydrant.
- No parking against the flow of traffic.
- No parking in a hazardous or dangerous location.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, State of New Jersey, that parking of vehicles shall be permitted on Seasons Drive beginning August 17, 2015 to September 18, 2015. All winter parking regulations remain in effect and the temporary amendment shall not permit or otherwise authorize anyone to park a vehicle in an unsafe manner or in a manner that disrupts the safe flow of vehicular or pedestrian traffic. The members of the Mount Arlington Police Department have the authority to remove any vehicle found parked in an unsafe manner or in a manner that disrupts the safe flow of vehicular or pedestrian traffic at the expense of the vehicle owner or operator.

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to the Chief of Police and A&R Management.
