- Attended the Halloween Bash along with Councilman Sadow, Councilman Windish, Councilman Delaney and spousal support; it was a great turnout and the Mayor publicly thanked the Recreation Department.

- Attended the Chamber of Commerce Economic Outlook luncheon and also attended the Morris County Economic Development Committee breakfast; both very enlightening. The Mayor is focused on economic development for our borough and we will be hearing a lot more about that as the year progresses.

- The Mayor performed the wedding ceremony for our former Fire Chief Steve Norman.

11. Municipal Administrator's Report

- Just a reminder that Sunday, November 20th at 2:00 p.m. is the Eagle Scout Award Ceremony for Ryan Mangano; the Clerk will prepare a proclamation for Mayor Stanzilis to present at the ceremony.

As requested at our Finance Committee meeting, we have a proposal for consideration and discussion for a Community Infrastructure Development Plan. The letter and outline prepared by CP Engineers has been distributed to the governing body. Borough Engineer James Landry gave a brief description of the proposal: to work hand in hand with a designated economic development committee with both internal discussions and discussions with the public regarding multiple potential infrastructure projects such as the beach, Fireman's Field, Howard Boulevard, i.e., 404 Howard, and how this all ties together. We have three areas with a certain level of connectivity and we plan to look at individual projects for the betterment of the Borough but also how these can fit together. The plan will tie together from an economic development perspective, a recreational perspective, health and wellness; many different areas can reap larger benefits by looking at these as a whole rather than individual projects. Mayor Stanzilis is pleased with the report and the prospective economic development of our Borough, which will be a major discussion over the next few years. Councilman Sadow stated this is a global approach to the development of the Borough but this approach involves the public, the planners and soon-to-be formed economic development committee. Mr. Landry stated the proposal is to take on the process; look at what we want as a Borough and then how to achieve those goals by looking at grants, etc. Mayor Stanzilis reiterated that every project is not a singular entity because the Borough is one big organism; all these projects are all related and have an impact throughout the whole community. Council would like a resolution on the December 6, 2016 meeting, with a proposal attached, to authorize the expenditures for the preliminary process.

- Ms. Rinaldi stated attended the Open Space Presentation along with Borough Planner Jessica Caldwell and Borough Engineer James Landry; Councilman Cangiano gave the presentation and we await the outcome in November.

12. Council Committee Reports

Councilman Delaney:

- All the CERT members have been retrained in CPR by the Police Department; only two members are waiting for recertification.
- Met with various committees during the month.

Council President Sorge:

- The Fire Department is doing very well. The FEMA Assistance Firefighters Grant deadline is November 18th; Matrix will prepare the grant application with the assistance of Chief Nick Lima and Assistant Chief Mike Lima. Ms. Rinaldi stated this is an annual, very extensive application, and there is a reimbursement for the fees associated with the application should we actually receive an award.

Councilman Sadow:

- Please Vote one week from today...
- FOP had a Golf Outing and thanked the Police Department.
- The Halloween Bash was outstanding.
- With regard to the schools, the most moving event, the Veteran's Day Ceremony, is coming up on November 9th and the Council and public are invited to join in; at MAPS at 9:00 a.m.
- The schools did go through their Park Test scores and there was discussion about the value of these Park scores; however, Mount Arlington scores are good and show a large jump in grades 5-6 which is sustained through grade 8 in much higher percentiles than state and county averages. High performance level in language arts and a good performance level in math. Councilman Sadow commended Math Teacher Julie Crawford on her sustainable efforts; they will be achieving sustainable bronze this year, and striving for silver for the very near future. Ms. Crawford is also responsible for the Green Team in grades K-8. Mr. Bernard Josefsberg, the interim superintendent, receives \$519 per diem. There is an active national search for a permanent superintendent and there have been more than 35 applicants. The search project is open to participation by the public; meetings on November 1, 2, and 11 for the public to actually participate and bring their qualification ideas to the meetings.
- All the water meters are in but there was a glitch with the software; bills are going out a little late.
- Seniors are exploding; membership is now over 220 active participants. Ms. Rinaldi and Councilman Sadow have had some preliminary discussions with the officers of the Seniors concerning consideration of a funding increase for 2017.
- The proposal from CP was the direct result of our Finance Committee meeting and the development of an action plan not only for the coming year in preparation of the budget but we always plan for 2, 5 and 10 year projects, some 20 or 30 year projects. The proposal from CP actually represents our desire to create a more rigid timeline on some of these projects and get them going. Councilman Sadow proposed that the Finance Committee, the Recreation Committee and the engineer form a sub-committee which would be the nucleus of the charrette concept for this project.

Councilman Windish:

- Councilman Windish stated he thinks it time to identify the recreation projects; while the sub-committee will be worthwhile, we need to focus on each project itself.
- December 2, 2016 is the tree lighting at Memorial Park, 6:45 pm, which is a joint effort between Recreation and the Borough. Recreation is proposing a holiday house lighting contest with several different categories. We will need to get sponsors but the start date December 19th, end date December 23rd. The Recreation programs are growing but the biggest impact is the increase in adult participation.
- Recreation is still searching for an online payment plan; doing this function manually is very cumbersome. They are looking into one specific company, Ms. Rinaldi will get additional information; startup costs could be \$2,500 \$3,000 range. Ms. Rinaldi stated the Recreation Commission has been actively pursuing this option but we run into a problem because the Commission is a municipal

entity and most programs on the market are not suitable for a municipal entity. We have one company that meets the criteria necessary.

14. New Business

CP Engineers Proposal for Borough Hall Space Planning.

CP Engineer James Landry stated the Borough Hall building was originally a bank building. We are presently utilizing the main office areas and the council chambers; very heavily used downstairs and sparsely used upstairs; there are steel joists and concrete between each floor so structurally, it basically opens up the entire section to do whatever you want with a lot of flexibility. CP has proposed taking a look at this on a space planning view and divided that into three areas: 1) looking at what you do and coming up with a system that can maybe help things be somewhat better; 2) maybe taking out a wall here, adding one there, maybe some more minor level of internal construction; and 3) doing some space planning that would make the upstairs fully accessible to the public, which would basically require an elevator and a secondary egress. CP will evaluate these 3 scenarios and provide them to the Council; we can adjust things as we go, coordinate with Council and provide a budgetary estimate. Councilman Windish asked if the engineers have looked at the footprint of the building: Mr. Landry stated hey have just glanced at the plans and noted the above 3 different areas. The third option would not expand the footprint by very much but by putting in an elevator and a secondary egress there would be an expansion of the outside walls. Mr. Landry stated that we can always add options, including more expansion of the outer walls. The building does have one load-bearing wall, in the vault in the basement. Mayor Stanzilis stated we will be looking for a long-term solution. Councilman Sadow stated we have to take into consideration if this building is going to be the municipal building for the Borough for the foreseeable future. The Mayor stated that the Borough is one large organism, this project will impact all the other pieces, all relative to each other. The Mayor publicly thanked Mr. Landry for his efforts on this issue. Ms. Rinaldi confirmed that a resolution authorizing CP Engineers to move ahead will be on the December 6, 2016 agenda.





CP Engineers, LLC (CP) is pleased to provide this proposal for professional architectural/engineering services to the Borough of Mount Arlington for the Borough Hall Space Planning Project. We thank you for this opportunity to submit this proposal and for allowing CP to provide our services to you.

Background

The current Borough Hall was originally designed and constructed to be utilized as a local bank. The Borough of Mount Arlington now utilizes the space as the main administrative offices and Council Chambers. Over the years, the borough has shifted office space, moved walls and made individual adjustments to the internal configuration of the building to meet its needs at the time. Currently, Borough Hall houses the administrative functions of the Borough clerk, the tax department, the construction department, the finance department, and the governing body (mayor's office, Borough Administrator, & the Council Chambers and Land Use Board).

The intent of this project is to illustrate the existing configuration and develop a space plan to provide the Borough with a choice of schemes for the layout and use of Borough Hall that will meet the current and near future needs of the Boroughs administrative and governing functions.

Scope of Services

CP proposes to deliver this project to the Borough through the following three phase process: Phase 1 - Development of Existing Schematic:

CP will scan the original bank maps and current evacuation plan sheets to establish a foot print and base model from which to formulate the existing structural configuration of the upper two floors of Borough Hall.



Following the establishment of the basic footprint and existing structural configuration, CP will perform a field survey of the utilization of the existing space documenting large furniture and equipment such as desks, filing cabinets and high volume copiers/printers.

Utilizing the scans and field survey information, CP will develop an existing floor plan of Borough Hall in its current configuration. This base model will provide a reference to assist with envisioning the changes that will be reflected in the proposed layouts.

Phase 2 - Preparation of Three Potential Layouts:

Using the base model of the existing Borough Hall configuration, CP will develop three potential layouts as described below:

- The first layout will involve minimal to no construction. This scheme will work within the
 confines of the existing walls inside the building to modify the current layout and
 workspace to allow for better functionality providing for additional customer and private
 meeting spaces.
- 2. The second layout will involve some construction to reconfigure the current layout within the confines of the building. This scheme will work within the confines of the building footprint, while adjusting or removing the internal walls to develop a space planning model maximizing the uses of each individual floor to best suit the Borough's administrative functions.
- 3. The third layout will involve a more comprehensive approach to not only maximize each floor's use, but will include the elements of an elevator and secondary egress from the second floor to make this level fully open and accessible to the public.
- 4. Upon completion of the three schemes, CP will submit and present the layouts to the Borough Administrator and selected stakeholders for review and comment. We anticipate a maximum of three (3) rounds of comments from the Borough.
- 5. Upon receipt of the comments from the each submittal, CP will revise the layouts accordingly and submit the updated schemes to the Borough.

Phase 3 - Develop Budgetary Construction Cost Estimates for Each Layout:

Upon completion of the final layouts, CP will prepare a budgetary construction cost estimate for the Borough to utilize in determining the necessary cost to be allocated to design and complete the scheme selected for implementation. The cost estimates will be updated as necessary with each submittal.

Changes to the scope of work or unanticipated conditions may require additional investigation. We agree not to proceed with additional work without your approval, and not to exceed this proposed fee without your authorization.

Clarification

The proposal assumes the schemes developed for the project be limited to three variations with three rounds of review and comment. CP can provide additional layouts as requested for an agreed upon additional cost.

Cost

Based on the foregoing, CP proposes to perform this work for a Lump Sum Cost of \$14,500. CP will bill the Borough once a month on a percent complete basis.

Schedule

CP is prepared to begin work immediately upon your authorization. We anticipate submitting the first set of proposed layouts to the Borough within approximately four (4) weeks of your authorization to proceed.
