

## **ORDINANCE NO.: 01-17**

### **AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, COUNTY OF MORRIS AND STATE OF NEW JERSEY, SUPPLEMENTING BOROUGH ORDINANCES #06-15 AND #11-16 APPROPRIATING \$45,000.00 FOR THE HOWARD BOULEVARD at ONEIDA AVENUE PROJECT**

**BE IT ORDAINED**, by the Mayor and Council of the Borough of Mount Arlington, County of Morris and State of New Jersey, as follows:

**SECTION 1.** The within Ordinance supplements Ordinance 06-15 adopted July 7, 2015 and Ordinance 11-16 adopted December 6, 2016 by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, New Jersey, copies of which are incorporated herein as if set forth at length by reference.

**SECTION 2.** The improvement and purpose described in Ordinance 06-15 and 11-16, Howard Boulevard at Oneida Avenue Project, all such work to include all improvements, equipment and appurtenances related thereto and/or necessary therefore, is the same improvement and purpose of the within Ordinance and is hereby authorized as a general improvement to be made or acquired by Borough of Mount Arlington, County of Morris, New Jersey (hereinafter referred to as the "Borough"). For the said improvement or purpose stated in this Section, there is hereby appropriated \$45,000.00 from the Capital Improvement Fund as detailed by CP Professional Services in correspondence dated December 7, 2016 regarding Change Order #3 and associated Professional Services Costs, a copy of which is incorporated herein and said sum being inclusive of all appropriations heretofore made therefore.

**SECTION 3.** The Capital Budget of the Borough is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board of the New Jersey Department of Community Affairs showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Borough Clerk and is available there for public inspection.



**ORDINANCE NO.: 06-15**

**AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, COUNTY OF MORRIS AND STATE OF NEW JERSEY, AUTHORIZING AND APPROPRIATING \$816,404.00 CONSTRUCTION COSTS AND \$203,270.00 ENGINEERING COSTS FOR A TOTAL OF \$1,019,674.00 FOR THE REALIGNMENT OF HOWARD BOULEVARD AT ONEIDA AVENUE PROJECT**

**WHEREAS**, the Mayor and Council for the Borough of Mount Arlington desires to begin the construction project on the realignment of Howard Boulevard at Oneida Avenue; and

**WHEREAS**, in order to finance the expenditures associated with the Howard Boulevard at Oneida Avenue Project, including but not limited to, all activities associated with the construction; the design and implementation of all necessary measures; and issuance of Request for Proposals; the General Capital Fund Reserve must be formally appropriated. The estimated cost for the project prepared by the Borough Engineer is \$816,404.00 construction costs and \$203,270.00 engineering costs for a total of **\$1,019,674.00**, as set forth in the attached twelve (12) page packet which includes a Project Costs Summary, dated June 10, 2015; Howard Boulevard Realignment Cost Evaluation for Increased Scope Construction and Services, dated June 2015; Engineer's Opinion of Probable Costs of Realignment of Howard Boulevard at Oneida Avenue, dated October 2014; Proposal for Professional Engineering Services, dated June 27, 2014; Howard Boulevard Realignment Costs Evaluation for Increased Scope, dated January 2015; and Engineer's Opinion of Probable Construction Costs for Howard Boulevard Reconstruction, dated May 27, 2015, a copy of all documents shall be incorporated herein as if set forth at length; and

**WHEREAS**, the Borough Engineer and the Borough CFO recommends the Mayor and Council for the Borough of Mount Arlington authorize the appropriation.

**BE IT ORDAINED**, by the Mayor and Council of the Borough of Mount Arlington, County of Morris and State of New Jersey as follows:

**Section 1:** The improvement and purpose described in Section 3 of this ordinance is hereby authorized as a general improvement to be made or acquired by the Borough of Mount Arlington, County of Morris, New Jersey (hereinafter referred to as the "Borough"). For the said

improvement or purpose stated in Section 3 of this ordinance, there is hereby appropriated \$816,405.00, said sum being inclusive of all appropriations heretofore made therefor.

**Section 2:** The improvement hereby authorized and the purpose for the financing of which said obligations are to be issued is as follows:

The construction of the Howard Boulevard at Oneida Avenue Project, including but not limited to, all activities associated with the construction; the design and implementation of all necessary measures; and issuance of Request for Proposals. For the said improvement or purpose stated in this Section, there is appropriated \$816,404.00 for construction costs, which is comprised of \$15,000.00, amount of capital improvement fund for preliminary plans as per Borough Resolution 2014-88, a copy of which shall be incorporated herein as if set forth at length; \$125,000.00, amount of capital improvement fund as per Borough Ordinance 09-14, a copy of which shall be incorporated herein as if set forth at length; \$556,624.00, as agreed upon with the County of Morris to be set forth in an Interlocal Agreement; and \$119,780.00 from the Borough of Mount Arlington Capital Improvement Fund; and \$203,270.00 for engineering fees and costs from the Borough of Mount Arlington Capital Improvement Fund. This totals for the \$1,019,674.00 for the entire project.

**Section 3:** The improvement authorized is expenditures associated with the Howard Boulevard at Oneida Avenue Project, including but not limited to, all activities associated with construction costs; the design and implementation of all necessary measures; and Request for Proposals.

The following additional matters are hereby determined, declared, recited and stated:

- (a) The purpose described in Section 2 of this ordinance is not a current expense and is property or an improvement which the Borough may lawfully acquire or make as a general improvement having a period of usefulness of at least five (5) years and no part of the cost thereof has been or shall be specially assessed on property benefitted thereby.
- (b) Amount not exceeding \$203,270.00 in the aggregate for interest on said obligations, costs of issuing said obligations, engineering costs, legal fees and other items of expense listed and permitted under N.J.S.A. 40A:2-20 of the Law may be included as part of the costs of said improvement and are included in the foregoing estimates thereof.

**Section 4:** Any grant or other moneys received for the purposes described in Section 3 hereof in addition to the funds expressly appropriated in Section 2 hereof, shall be applied to direct payment of the cost of the improvement.

**Section 5:** The Capital Budget of the Borough is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board of the New Jersey Department of Community Affairs showing full detail of the amended capital budget and capital program as approved by the

Director of the Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.

**Section 6:** The provisions of this Ordinance are severable. To the extent any clause, phrase, sentence, paragraph or provision of this Ordinance shall be declared invalid, illegal, or unconstitutional, the remaining provisions shall continue in full force and effect.



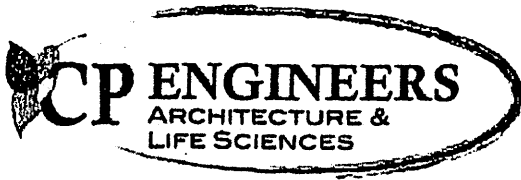



CP Engineers, LLC (CP) has received and reviewed the request from Tomco Construction, Inc. for Change Order #3. This request relates to the cost to perform asphalt repairs in Howard Boulevard following milling operations.

In milling Howard Boulevard, the pavement thickness was such that the existing asphalt pavement was completely removed in multiple locations. After coordinating with the contractor and the Morris County project manager, Tomco was directed to make full depth pavement repairs in designated areas marked out by the County's inspectors. The work was done on a time and materials basis under the observation of the County's inspector. The County has reviewed and agreed with the change order request submitted by Tomco.

We believe the cost is consistent with the work performed and was beyond the original scope of the project. Based upon the information summary provided, we recommend approval of the request for Change Order #3 in the amount of \$30,704.40 including an increase of 3 days to the time provided for completion of the project. Upon approval, the contract will increase from \$794,156.90 (\$770,817.72 original contract plus \$7,769.95 change order #1 and \$15,569.23 change order #2) to \$824,861.30.



Please find enclosed the contract change order and the request for Change Order #3 from Tomco Construction, Inc.




