2017-56 Resolution of the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, State of New Jersey, Authorizing A Ground Lease Agreement with HESP Solar, LLC

Motion to Approve: Council President Sorge

Borough Bond Counsel Matthew Jessup, Esq., stated this resolution authorizes execution of a ground lease in the redevelopment area known as the Mount Arlington Landfill Redevelopment area. This is a ground lease that provides access to the designated developer HESP Solar; this would grant HESP access to the site for a term of twenty-five years for a limited purpose to build a PV facility that would be grid connected. It will pay an upfront lease payment to the Borough in the amount of \$227,000. There is an option that can be exercised in the future for an increased rental payment of \$318,000 and a second option for an upfront rental payment of \$580,000. There is also an additional rent provision that provides for a negotiation of savings in connection with certain road and lighting improvements. Mount Arlington remains responsible to monitor the landfill cap and keep it up to date, as always; HESP is certainly fully responsible in the event that they cause a disruption to the cap. HESP will be required to provide standard insurance for the benefit of the Borough that will also indemnify the Borough in the event of any liability caused by them. The Borough does have an option to purchase the PV facility at the end of fifteen years through the twenty-fifth year of the term for fair market value; in the event that the Borough does not exercise that option, HESP removes the PV facility at the end of twentyfive years and restores the site to its normal condition, subject to normal wear and tear which is allowed. Upon adoption of this resolution tonight, this would allow HESP to make application to PJM no later than March 31, 2017 to get them in the next cue of projects within the PJM distribution system. The Mayor clarified that

the Borough spends \$25,000 per year on the landfill which is ongoing; this is not incorporated into the Agreement. Susan Brodie, a principle with HESP, was in attendance as well. The Mayor thanked Ms. Brodie and stated we are looking forward to a mutually beneficial partnership with HESP.
