1. Call to Order

2. Adequate notice of this meeting of the Mayor and Borough Council of the Borough of Mount Arlington was given as required by the Open Public Meetings Act as follows: Notice was published in the Roxbury Register on January 4, 2017 and posted on the bulletin board in the main hallway of the Municipal Building on December 21, 2016. Notice of this meeting is on file in the Office of the Borough Clerk and has been made available to the public.

In accordance with the Open Public Meetings Act (N.J.S.A. 10:4-1 et seq.), the Borough Council opens every public meeting for comments of the public. Speakers at Borough meetings shall have five minutes to present their comments to the Borough Council so as not to consume time that would otherwise be allotted to other persons who wish to speak.

At the mandate of Council President, all Councilpersons shall not discuss or address in the Public portion of this meeting any matter that is: 1) pending litigation; 2) ongoing investigation of any type; 3) potential litigation; and 4) personnel or any comments regarding any Borough employee without being given Rice Notice. Should any Councilperson discuss any of these issues in Open Session, the Borough Chief of Police will remove that Council person from the dais.

- Just a reminder that the November 1st Council Meeting is on a Wednesday evening.
- Best Practices Inventory:

The Administrator read into the record: Each municipality is required to complete and submit a Best Practices Inventory worksheet to the Division of Local Government Services to determine whether or not some portion of the municipality's aid will be withheld. The Inventory encourages municipalities to embrace practices that promote financial accountability, sound management and transparency. As the Chief Financial Officer, Ms. Rinaldi is responsible for completing the questionnaire and apprising the governing body of the outcome. The deadline for submission is October 20, 2017.

There have been some changes to the questionnaire but all of the questions have been asked on previous questionnaires but it the number of questions has been reduced; originally there were 50 questions, reduced to 30 and this year it is down to 25 questions. Questions pertain to contracts, Borough policies, website, Borough efforts at transparency, information from the assessor, confirmation that Council members have submitted their Financial Disclosure Statements, annual debt statements, health benefits, and overall policy and procedures for the Borough. Mount Arlington is in compliance with Best Practice Standards and will continue to receive 100% of our aid.

13. Council Committee Reports

Councilman Delaney:

- The CERT Team will be out in full force to help with the Wargo Memorial 5K. We also have four new volunteers for the CERT Team, going through background checks, etc. now and will start training at the end of the month.

Councilman Loughridge:

- We are starting to get some positive results with Property Maintenance issues.
- Councilman Loughridge stated he is the Chairman of the Trails Committee and on September 23, 2017, the first section of the trails in Hopatcong were completed. The new trail is named the Lake Hopatcong Trail which is 9 miles long and funded by the Federal Highway Administration Recreational Trails Program.

Councilman Cangiano:

- Attended a TransOptions Awards Ceremony on behalf of the Borough, along with Mayor Stanzilis. This Association is involved with environmental education, sustainability, bicycle safety, pedestrian safety, etc. Julie Crawford of Mount Arlington Public School was given an award for her efforts with the programs' sustainability and Green Team efforts.

Councilman Sadow:

- The Finance Committee is planning to meet on October 27th to look at potential capital projects for 2018 and beyond; both CFO Rinaldi and Budget Consultant Kovalcik will be present as well.


Eagle Project Proposal

Mount Arlington Community Garden


Proposal


