**WHEREAS**, the Borough of Mount Arlington received bids for the 2018 CDBG Road Improvements Project on March 21, 2019; and

**WHEREAS**, the Borough rejected all bids by resolution 2019-71, adopted on April 2, 2019; and

**WHEREAS**, the Borough of Mount Arlington held the re-bid opening for the 2018 CDBG Road Improvements Project on April 30, 2019 at which time no bids were submitted; and


**WHEREAS**, the Borough Engineer, by letter dated May 1, 2019, as attached, has recommended that the project be re-bid again.


Dear Ms. Rinaldi:
