

## ORDINANCE 12 - 19

**AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING THE CODE OF THE BOROUGH OF MOUNT ARLINGTON CHAPTER 72 DIAL-A-RIDE VAN SECTION §72-4. RULES AND REGULATIONS. SUBSECTION B, ITEM “RESERVATIONS” AND ITEM “PASSENGER REQUIREMENTS”**

WHEREAS, the Borough Code Chapter 72 Dial-A-Ride Van Section §72-4. Rules and Regulations. Subsection B, Item “Reservations” and Item “Passenger Requirements” are outdated and need to be amended to list the current Borough hours, telephone numbers and policies; and

WHEREAS, the Mayor and Council for the Borough of Mount Arlington desires to amend and supplement the current code Chapter 72 Dial-A-Ride Van Section §72-4. Rules and Regulations. Subsection B, Item “Reservations” and Item “Passenger Requirements”.

BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris and State of New Jersey as follows:

**SECTION 1.** Chapter 72 Dial-A-Ride Van Section §72-4. Rules and Regulations. Subsection B, Item “Reservations” and Item “Passenger Requirements” are hereby amended and supplemented to read in pertinent part as follows:

### **§72-4. Rules and Regulations.**

B. The rules and regulations for the Dial-a-Ride program shall be kept on file in the Borough Clerk's Office, distributed to all program participants and available to the public for copying and inspection.

### **RESERVATIONS**

The Dial-A-Ride program operates Monday through Friday between 7:30 a.m. and 3:30 p.m. except on Holidays.

All reservations must be made forty-eight (48) hours in advance. Please note your reservation is not confirmed until you have been notified by the driver.

All reservations must be made through the Dial-A-Ride phone number 201-841-5114.

Please leave a detailed voice message and someone will return your call the next business day.

### **PASSENGER REQUIREMENTS**

1. Passengers must be on time for scheduled appointment.
2. Passenger aisles on the Dial-A-Ride vehicle must be kept clear at all times. No packages, legs or arms in the aisle.

3. Verbal and/or physical abuse of the driver and/or other passengers will not be tolerated. If you have a problem you can call the Dial-A-Ride Supervisor's Office at 973-398-4200 after exiting the vehicle.
4. Smoking and/or alcohol is prohibited on the Dial-A-Ride van.
5. Eating or drinking is prohibited on the Dial-A-Ride van.
6. Passengers must remain seated and must wear seatbelts at all times.
7. Each passenger may carry a maximum of five (5) grocery bags on the vehicle and shall not place their bags on another seat.


**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistencies.

**SECTION 3.** If any article, section, subsection, paragraph, phrase, or sentence is for any reason held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed separable.

**SECTION 4.** This Ordinance shall take effect upon final publication as provided by law.
