

ORDINANCE NO.: 13 - 19

AN ORDINANCE OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING THE BOROUGH CODE CHAPTER 169, VEHICLES AND TRAFFIC, SECTION §169-23. STOP INTERSECTIONS; AND SECTION §169-13. PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS

WHEREAS, the Borough Engineer and the Borough of Mount Arlington Police Chief reviewed the Borough of Mount Arlington Code and discovered intersections missing from the section; and recommend that Chapter 169 Vehicles and Traffic, Section §169-23. Stop Intersections, be amended to include the following intersections:

Intersection	Stop Sign(s) On
Trailwood Drive and Elizabeth Way	Elizabeth Way
Trailwood Drive and Orben Drive	Trailwood Drive

WHEREAS, the Borough of Mount Arlington Police Chief reviewed the Borough of Mount Arlington Code after issues of parking causing safety hazards were raised at a Borough Council meeting; and issues with necessity for Fire Department truck and vehicle access and emergency parking were raised by the Fire Department; and recommends that Chapter 169 Vehicles and Traffic, Section §169-13. Parking prohibited at all times on certain streets, be amended to include the following streets into the table in alphabetical order:

NAME OF STREET	SIDES	LOCATION
Prospect Ave	Both	From Mountainview to Summit
Prospect Ave	One Side	The bottom portion by Howard along the rock wall.

WHEREAS, the Mayor and Council for the Borough of Mount Arlington has reviewed the recommendations of the Borough Engineer and the Borough of Mount Arlington Police Chief and believes that these traffic regulations are necessary in order to protect the health, safety and welfare of its residents, as well as the safety of the public at large; and therefore desires to amend and supplement the Borough Code to amend Chapter 169 Vehicles and Traffic, Section §169-23. Stop Intersections, to include the intersections set forth above; and Section §169-13. Parking prohibited at all times on certain streets, to include the streets set forth above.

BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, and the State of New Jersey, that Chapter 169 Vehicles and Traffic, Section §169-23. Stop Intersections, to include the following intersections (to be listed in the Code in alphabetical order):

Intersection	Stop Sign(s) On
Trailwood Drive and Elizabeth Way	Elizabeth Way
Trailwood Drive and Orben Drive	Trailwood Drive

BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, and the State of New Jersey, that Chapter 169 Vehicles and Traffic, Section §169-13. Parking prohibited at all times on certain streets, be amended to include the following streets into the table in alphabetical order:

NAME OF STREET	SIDES	LOCATION
Prospect Ave	Both	From Mountainview to Summit
Prospect Ave	One Side	The bottom portion by Howard along the rock wall


SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistencies.

SECTION 3. If any article, section, subsection, paragraph, phrase, or sentence is for any reason held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed separable.

SECTION 4. This Ordinance shall take effect upon final publication as provided by law.
