CP Engineers, LLC (CP) is pleased to provide this proposal for professional engineering services to the Borough of Mount Arlington for the 2020 McGregor Trails Project. The parcels involved in this project are Block 2, Lot 42, and Block 2, Lot 44

The proposed project is for the construction of new non-motorized, or diversified recreational trails and trailhead parking on the noted parcels. The proposed project plans will be utilized by the Borough of Mount Arlington in their submission to the 2019 Morris County Trail Construction Grant Program.

#### Scope of Services

### Task 1 - Surveying and Preliminary Engineering

CP will coordinate with our survey subcontractor to conduct a survey along our pre-designed trail corridor. This detailed field survey for topography will be limited to confirming the preliminary design/layout of the proposed trails and allow for fine adjustment. We will also perform a boundary survey of the subject properties. Existing conditions and topographic survey will also be performed at the proposed trailhead locations.

## Task 2 - Base Mapping

Utilizing the boundary and topographic survey as a base plan, and supplementing with publicly available LIDAR topographic mapping, CP will prepare a base map for the project. Available information pertaining to environmental, physical and other regulatory constraints will be added to the base mapping, as appropriate. In addition, publically available aerial photography and information pertaining to field observations by CP personnel will be included in the base map.

<u>Task 3 – Preparation of Contract Design Documents and Morris County Parks Commission Application</u>
This task involves the preparation of plans and specification for the construction of the project, based upon the information gathered in the prior tasks. The design of new trails will be in conformance with

USFS trail design and access requirements and applicable Morris County Soil Conservation regulatory permitting requirements. It is anticipated that various trail surface materials and trail classes will be utilized. It is proposed that four access points to the trails be included (i.e., trailhead area on McGregor at the west side of the property, at the southeast corner of the property, at the northwest corner of the property to the Hover Drive cul-de-sac and at the northeast corner of the property. The contract documents will be in a format acceptable for submission to the Morris County Trail Construction Grant Program. This task includes the preparation and submission of the required letter of intent and the submission of design plans and specifications to the Morris County Parks Commission. In addition, we have included up to two meetings with the Parks Commission.

# Task 4 - Regulatory Permitting

This task involves the preparation and submission for Soil Erosion and Sediment Control Plan approval for the enhancement and/or construction of trails within the McGregor Trails parcels. This permit will address work associated with soil disturbance during project construction.

## Cost

Based on the foregoing, CP proposes to perform this work on a Lump Sum basis as derived from the following breakdown of cost per task:

Task 1 – Survey and Preliminary Engineering	\$ 50,000.00
Task 2 - Base Mapping	\$ 6,500.00
Task 3 – Preparation of Constr. Design Documents / Parks Commission Submissions	\$ 25,000.00
Task 4 - Regulatory Permitting	\$ 3,000.00

# **Clarifications**

- 1. The scope assumes that the Borough will provide title work for the subject properties.
- 2. The scope of services does not include required regulatory application fees which will be the responsibility of the Borough.
- 3. The scope excludes historic and archeological assessments, surveys, or coordination with the New Jersey Register of Historic Places.
- 4. This scope does not include investigations (other than those specifically identified above) to determine if environmental issues are present.
- 5. This scope does not include the cost of the bidding and construction administration/inspection services for the project.
