
**A RESOLUTION OF THE MAYOR AND BOROUGH COUNCIL OF THE
BOROUGH OF MOUNT ARLINGTON, COUNTY OF MORRIS, NEW JERSEY,
AUTHORIZING THE BOROUGH TO ENTER INTO AN INTERLOCAL SERVICES
AGREEMENT WITH THE BOROUGH OF WHARTON FOR PROVIDING STREET
SWEEPING OF VARIOUS ROADS**

WHEREAS, the Borough of Wharton has received a request from the Borough of Mount Arlington for providing street sweeping of various roads within the Borough of Mount Arlington; and

WHEREAS, the length of this Agreement shall be effective on the date of execution through December 31, 2013.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, New Jersey, that the aforesaid Agreement with the terms set forth in the attached Agreement be accepted and that the Mayor and Borough Clerk are hereby authorized to execute said Agreement.

AN INTERLOCAL SERVICES AGREEMENT BETWEEN THE BOROUGH OF WHARTON AND THE BOROUGH OF MOUNT ARLINGTON FOR THE PURPOSE OF STREET SWEEPING OF VARIOUS ROADS.

THIS AGREEMENT, made this 1st day of April, 2012 between the MOUNT ARLINGTON BOROUGH hereinafter referred to as the MTA BOROUGH and the BOROUGH OF WHARTON, hereinafter referred to as the "BOROUGH".

WHEREAS, pursuant to Interlocal Services Act, N.J.S.A. 40:8A-1 et seq., local units may join together to provide authorized services for each other; and

WHEREAS, the BOROUGH and the MTA BOROUGH desire to join together in an agreement whereby the BOROUGH will perform on behalf of the MTA BOROUGH the sweeping of various roads within the MTA BOROUGH

WHEREAS, this agreement must be authorized by a Resolution adopted by the Mayor and Borough Council of the MTA BOROUGH, and a Resolution adopted by the Mayor and Borough Council of the BOROUGH; and

WHEREAS, the necessary resolutions have been adopted prior to the execution of this agreement:

WITNESSETH, that the Borough hereby agrees as follows:


A. To perform street sweeping as directed by the MTA BOROUGH for roads located within the MTA BOROUGH and will furnish a street sweeper and one operator to perform same.


1. The rates noted below will apply when BOROUGH employees and equipment are utilized in the street sweeping operations. The MTA BOROUGH agrees to reimburse the BOROUGH at the following rate:
