CP Engineers (CP) has reviewed the single bid submitted for the above referenced project. The results of the bidding are as follows:

<u>Bidder</u>	<u>Bid Total</u>
Shauger Property Services, Inc.	\$721,800.00

Shauger Property Services, Inc. (Shauger) is the apparent low bidder. The evaluation performed by this office concluded that the lowest bidder is responsive and responsible. This bid contains contingency pricing for excavating through rock and requirements for additional gravel and is lower than the project construction estimate with contingency. We contacted multiple references provided by the bidder. Comments from the contacted references were overwhelmingly positive, stating that Shauger was the commenter's favorite contractor with whom to work; that they were responsible, easy to work with, and trustworthy; that they were cognizant of the roads around them and maintain a very clean jobsite. We recommend that the Windemere, Altenbrand, and Park Water Main Extension Project be awarded to Shauger Property Services, Inc. of East Orange, New Jersey.
