# BOROUGH OF MOUNT ARLINGTON COUNCIL MEETING MINUTES

# December 1, 2020 7:00 PM

The Regular Meeting of the Borough of Mount Arlington was held on Tuesday, December 1, 2020. This meeting was held remotely/electronically using the platform Zoom and commenced at 7:00PM.

- 5. By having provided comments in writing and mailed same for delivery no later than the date of this meeting, as provided in the notice.

Procedures, requirements and standards for making public comment in remote meetings shall be governed by applicable law, including Local Finance and regulatory guidance. In connection with this remote meeting, the Borough will be utilizing an electronic communications platform that utilizes audio muting in connection with the control of this meeting, including the orderly conduct of public comment."

#### Mayor's Report

Mayor Stanzilis wished everyone a happy Thanksgiving and thanked the police for working that day, as well as the Council members who went around and gave the police officers food. Mayor Stanzilis recently attended a small business rally in Morristown/Morris Township hosted by a group of citizens and businesses who were concerned that the State of New Jersey was not

helping small businesses during the pandemic. Some of the businesses represented had actually already gone out of business. The Mayor wished to remind Governor Murphy that the cure cannot be worse the than disease; small businesses everywhere in New Jersey were getting crushed. The Mayor recently joined Council President Delaney at The Bagel Place to show their support of this small business that had kept its doors open for the residents during the pandemic. The Mayor also recently attended a meeting with the other mayors from around Lake Hopatcong to discuss stormwater management, clean water, and grants to look into in 2021. The Mayor recently attended the Inaugural Green Infrastructure Committee meeting which was also attended by the Rutgers Cooperative Extension and Council President Delaney amongst others. He thanked Ms. Rinaldi for putting the meeting together. The recent Girl Scouts Little Library event was a great success. The Little Library was like a big doll house/small shed where anyone could go and get a book. He thanked the Girl Scouts for everything that they did and stated they were an integral part of the community.

## **Chief of Police Report**

Chief LaBruno congratulated new Police Officer Nicholas Pizzuto and stated he would be a great asset to the Police Department. Due to the pandemic the agency had returned to a modified schedule so, if there were a positive case of COVID-19 within the agency, they could still continue to serve the community. Chief LaBruno was spending time helping the Jersey City Police Academy by teaching some courses out of the Morris County Training Academy. Chief LaBruno went on to announce the Police Department would continue "No Shave November" by extending it through the end of December to raise donations for the Special Olympics. They were getting local sponsors and the Police Union was matching donations.

Mayor Stanzilis stated that COVID-19 cases had gone up recently, but compared to other towns of similar size the Borough was in very good shape. Mayor Stanzilis asked everyone to please keep practicing good hygiene, social distancing and to use common sense.

Fire Chief Giacobbe announced their Annual Santa Run would be Saturday, December 19<sup>th</sup> from 10:30am until 5:00pm. Also, on December 13<sup>th</sup> at 2:00pm, Santa would also be making a special visit to the Ridgeview condominium community, starting at the Mount Arlington Public Library, and visiting the various condominium buildings up the road over the course of about thirty minutes.
