7. Approval of Sanitarian's and Nursing Report

A. COVID-19 Update

Mr. Weigle reported that the COVID-19 case numbers are down from his last report. He has been working with the school districts, under the Mount Olive Board of Health jurisdiction, developing a re-opening plan as related to the COVID-19 guidelines.

B. March through August 2020 Public Health Services Report

Mr. Weigle reviewed the Sanitarian's report for March through August. He reported that the Mount Olive Health Educator resigned, but Christie Jamie will be joining his organization October 1, 2020 as the new Health Educator. Mount Olive has hosted three Child Health Clinics and anticipates scheduling a few more before the year is out.

Mount Olive Board of Health received help from local school nurses during the height of the pandemic to conduct contract tracing. The nurses were trained to interview COVID-19 patients and were very helpful.

Mr. Weigle said that Mount Olive has not yet received the flu vaccinations, but will set up clinic once the vaccinations are received.

Mr. Webb reported that the Cottage Food Law will be going into effect by the end of the year. He went on to report that the retail food inspection numbers are low because a number of establishments are closed due to COVID-19 so routine inspection are not being performed. This is also the case with the recreational bathing inspection numbers; some of the pools are closed due to COVID-19 so the inspection numbers are down here as well.
