## **ORDINANCE 04-2021**

AN ORDINANCE OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, NEW JERSEY APPROPRIATING \$105,000 FROM THE CAPITAL IMPROVEMENT FUND FOR THE ACQUISITION OF IN-VEHICLE AND BODY CAMERAS FOR THE POLICE DEPARTMENT

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, NEW JERSEY AS FOLLOWS:

Section 1. The Borough of Mount Arlington, in the County of Morris, New Jersey (the "Borough") hereby appropriates the amount of \$105,000 from the Capital Improvement Fund for the acquisition of in-vehicle and body cameras for the Police Department, including all related equipment and further including all costs and expenses necessary therefor and incidental thereto.

Section 2. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 3. This ordinance shall take effect after final adoption and publication and otherwise as provided by applicable law.
