RESOLUTION OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AUTHORIZING A FEE SCHEDULE AND CAPACITY LIMITS FOR ACCESS TO THE MUNICIPAL BEACH CONSISTENT WITH MUNICIPAL ORDINANCE

WHEREAS, the Borough of Mount Arlington, County of Morris, State of New Jersey is a public body corporate and politic of the State of New Jersey; and

WHEREAS, the Municipal Beach is open to residents of the State of New Jersey, and reasonable access shall be afforded for residential and non-residential use of the Municipal Beach; provided however, that capacity limits may be set by Resolution of the Governing Body to ensure public safety, and fees are otherwise set consistent with the provisions of Borough Ordinance No. 06-2020; and

WHEREAS, pursuant to Ordinance No. 06-2020, adopted by the Borough Council on October 6, 2020, reasonable fees may be charged to any person seeking access to the Municipal Beach and recreational facilities from Memorial Day through Labor Day (consistent with the terms of that Ordinance), so as to provide funds to improve, maintain and police the Municipal Beach and to provide facilities and safeguards for recreation, including the employment of lifeguards and other necessary personnel; and

WHEREAS, consistent with Ordinance No. 06-2020, such fees must be set by Resolution of the Borough Council, all in accordance with applicable law, and must also take into consideration those amounts already paid by any person paying ad valorem taxes to the Borough to provide funds for the above referenced purposes, as directed by Ordinance; and

WHEREAS, per Ordinance, capacity limits may also be set by Resolution of the Borough Council to ensure public safety; and

WHEREAS, in furtherance of the foregoing, the Borough desires to set the following fee and capacity schedule for the 2021 Municipal Beach season:

Non-Resident Daily Beach Badge \$10.00 per day Monday through Friday

\$20.00 per day Saturday and Sunday

(per car and includes Placard)

Resident Daily Beach Badge Required (see Ordinance No. 06-2020 as to fees)

Non- Resident Parking Placard Required Resident Parking Placard Required

Beach Capacity Limit Ninety (90) people, up to thirty (30) non-residents

Parking Lot Capacity Twenty-three (23) spaces, up to 10 (10)

non-resident cars

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the Council of the Borough of Mount Arlington, as follows:

- 1. The aforementioned recitals are incorporated herein as though fully set forth at length.
- 2. The Borough hereby authorizes the fees and capacity limits set forth herein, all consistent with Ordinance No. 06-2020.
- 3. If any part of this Resolution shall be deemed invalid, such parts shall be severed and the invalidity thereby shall not affect the remaining parts of this Resolution.
- 4. A copy of this Resolution shall be available for public inspection at the offices of the Borough Clerk.
- 5. This Resolution shall take effect immediately, as provided by law.
