

RESOLUTION 2021 – 108

**A RESOLUTION OF THE MAYOR AND BOROUGH COUNCIL OF THE
BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, STATE
OF NEW JERSEY, ACCEPTING THE BID AND AWARDING THE CONTRACT
FOR THE 2021 WATER AND SEWER SYSTEMS EMERGENCY REPAIR
SERVICES TO JOHN GARCIA CONSTRUCTION CO.**

WHEREAS, the Borough of Mount Arlington has determined that it is necessary to have water and sewer systems emergency repair services for the Borough; and

WHEREAS, the Borough of Mount Arlington advertised and accepted bids for the desired project, and on October 13, 2021, the Borough of Mount Arlington opened and reviewed three (3) bids to perform the 2021 Water and Sewer Systems Emergency Repair Services. All bids were reviewed for the following: (1) all bid prices (written) were compared with bid prices (figures) for accuracy; and (2) completion of all forms within bid documents. The lowest responsive and responsible bidder, according to the bid tabulation prepared by the Borough Engineer Mr. Matthew T. Peles, P.E., is John Garcia Construction Co.; and

WHEREAS, Borough Engineer Mr. Matthew T. Peles, P.E., in correspondence dated October 15, 2021, a copy of which is attached to the Resolution and incorporated herein by reference, recommends the Contract be awarded to John Garcia Construction Co. as the lowest responsive and responsible bidder, at a cost of \$74,302.35; and


WHEREAS, the Chief Financial Officer recommends this award on the grounds that it represents the best price available; and

WHEREAS, the Chief Financial Officer certified the availability of funds for the contract amount, not to exceed \$74,302.35.
