A RESOLUTION OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF MOUNT ARLINGTON, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, ACCEPTING THE BID, AND AWARDING THE CONTRACT FOR. THE LOGAN WAY RESTORATION PROJECT TO RIVERVIEW PAVING, INC.

WHEREAS, the Borough of Mount Arlington ("Borough") has determined that it is necessary to undertake the restoration of Logan Way within the Borough ("Project" or "Logan Way Restoration"); and

WHEREAS, the Borough advertised for and accepted bids for the Project, and on June 29, 2021, opened and reviewed the two (2) bids received to perform the Logan Way Restoration. All bids were reviewed for the following: (1) legal sufficiency and responsiveness; (2) all bid prices (written) were compared with bid prices (figures) for accuracy and consistency, including a review of unit and extended price totals; (3) technical sufficiency and responsiveness; and (4) to ensure the completion of all forms required within and by the bid documents for the Project. The lowest responsive and responsible bidder, pursuant to the bid tabulation prepared by the Borough Engineer Mr. John M. Cahillane, P.E., and when considering the forgoing elements of review of the bids, is Riverview Paving, Inc. of Hackettstown, New Jersey ("Riverview"); and

WHEREAS, the Borough Engineer, in correspondence dated July 1, 2021, a copy of which is attached to this Resolution and incorporated herein by reference as if set forth at length, recommends that the Contract for the Project be awarded to Riverview as the lowest responsive and responsible bidder, at a total cost (base bid) of \$368,256.40; and

WHEREAS, the Chief Financial Officer (and the Borough Engineer) recommend this award on the grounds that it represents the best price available, and is consistent with the engineering and cost estimates for the Project; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for the Contract amount, not to exceed \$368,256.40.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Borough Council of the Borough of Mount Arlington, County of Morris, State of New Jersey, that the Contract for the Logan Way Restoration is hereby awarded to Riverview Paving, Inc. of Hackettstown, New Jersey. The Mayor, Clerk and all other necessary Borough personnel, be and hereby are directed and authorized to enter into a Contract with Riverview for the Project, and to in all other ways carry out and effectuate the purposes thereof.

This Resolution shall take effect immediately.
