9. Approval of Sanitarian's Reports:

a. November and December 2021

Mr. Weigle reviewed the November and December 2021 Sanitarian's Report. He explained that November and December saw the largest increase in infections of the pandemic to date. They saw more cases in this period than all the cases in 2020. In some townships Mount Olive services, they saw more OMICRON cases in the month of December than all of 2020. Fortunately, things have calmed down.

Mount Olive BOH members spent a significant amount of time with school representatives to determine if they should remain open, close, or run classes virtually. Mount Olive was also involved in contract tracing; basically a lot of COVID work which filled their schedules.

Mr. Webb reported that in December they did not see severe COVID outcomes due to exposure; those who did become infected had mild infections. Mr. Webb went on to report that they met with representatives from Atlantic Health who reported that one out of three people they saw was diagnosed with COVID.

Moving on to the Environmental Health Section of the Sanitarians report, Mr. Webb said Tiger Mart received a conditional rating due to house-keeping issues including refrigeration temperature concerns. They have been reinspected and received a satisfactory rating.

Mount Olive followed up on a hand rail complaint at Shore Hills Apartments. After inspecting and measuring the stairs it was determined that hand rails were not required based on the Multi Dwelling code.

Mount Olive also received a mold complaint from a resident of the Mount Arlington Garden Apartments. New Jersey does not have a mold standard, but the Board of Health recommends the apartment dweller test for mold both inside and outside their apartment, identify the sources of moisture, and remediate the moisture.

Mr. Weigle reported staffing changes in the Mount Olive Board of Health including the retirement of Bob Stahlhut in December 2021 and the resignation of Darling Zambrana whose RHS position will be filled. In addition, Mr. Weigle reported that Mount Olive is no longer supporting the town of Dover.

Atlantic Health Systems hospitals have received a huge increase in emergency room patients. Most of those individuals diagnosed with COVID are sent home where symptoms are treated.

Mrs. Tuorinsky asked about the December COVID outbreaks at Mount Arlington Senior Living facility. Mr. Weigle said the outbreak was not as severe as the previous outbreaks with four individuals getting sick; their symptoms were not serious. In comparison, 15 individuals got COVID in calendar year 2021 and 32 in calendar year 2020.
