Discussion: Ordinance of Mayor & Council of the Borough of Mt. Arlington, Vacating a Portion of Old Howard Blvd.

Wade Baldwin attorney standing in for Mike Selvaggi explained that a portion of Old Howard Blvd. will be vacated. The new Right of Way will go around the property known as Block 67, Lot 1 owned by the Borough of Mt. Arlington. Chairman asks who will that property go to, Mr. Baldwin states that the adjacent property has opportunity to purchase that property. Board questions if the adjacent lot owners Block 61.01, Lot 3 and Lot 4 will purchase the property and combine with the vacated portion of Old Howard Blvd. John Cahillane from CP Engineers states that is the intention. Mr. Baldwin responds that it is already determined by the Borough

that they want to vacate that portion of old Howard Blvd. and whether or not it is consistent with the Master Plan.

Board Members agree that the it is a benefit to the Borough to sell Block 67, Lot 1 as it serves no purpose on its own and that the adjacent property owner will be able expand their property creating tax revenue. The road will only be vacated upon sale of Block 67, Lot 1. The Board has no objection to a portion of Old Howard Blvd. being vacated.
