BOROUGH OF MOUNT ARLINGTON REORGANIZATION MEETING MINUTES JANUARY 3, 2023 6:00 P.M.

The Reorganization Meeting of the Borough of Mount Arlington was held on Tuesday, January 3, 2023. This meeting was held in-person at the Municipal Building at 419 Howard Boulevard, Mount Arlington, New Jersey.

Councilman Delaney called the meeting to order at 6:06PM.

Mr. Bansch, Borough Clerk, stated "adequate notice of this Reorganization Meeting of the Mayor and Borough Council of the Borough of Mount Arlington was given as required by the Open Public Meetings Act as follows: Notice was published in the Daily Record and the Roxbury Register on December 22, 2022 and posted on the bulletin board in the main hallway of the Borough Municipal Building; notice of this meeting is on file in the Office of the Borough Clerk. In accordance with the Open Public Meetings Act (N.J.S.A. 10:4-1 et seq.), the Borough Council opens every public meeting for comments of the public. However, in accordance with N.J.S.A. 10:4-12: 'Nothing in this Act shall be construed to limit the discretion of a public body to permit, prohibit or regulate the active participation at any meeting.' Speakers at Borough meetings shall have five minutes to present their comments to the Borough Council so as not to consume time that would otherwise be allotted to other persons who wish to speak."

Councilman Delaney led everyone in the Pledge of Allegiance. He asked everyone to remain standing to observe a moment of silence for the troops.

Mayor Stanzilis acknowledged some of the honored guests in the audience including Morris County Commissioner Tayfun Selen, Morris County Commissioner Stephen Shaw, Morris County Commissioner Douglas Cabana and Lake Hopatcong Foundation Chair Marty Kane. Mayor Stanzilis also announced Senator Anthony Bucco, Jr. and Assemblywoman Aura K. Dunn had reached out earlier to wish everyone well.

Presentations:

Mayor and Borough Council Recognition of Borough Council Member Maria Farris

Mayor Stanzilis presented Ms. Farris, who resigned from her position as Borough Council Member effective January 1, 2023, with a proclamation recognizing and thanking her for her four years of public service on the Mount Arlington Borough Council, and for her numerous contributions and years of selfless service to the Borough. Mayor Stanzilis then presented Ms. Farris with a Challenge Coin for Mayor's Community Service Excellence.

Nomination of Council President for 2023

Mayor Stanzilis expressed his appreciation for Council President Delaney, who attended almost every Borough meeting, including committee meetings.

Mayor's Address

Mayor Stanzilis stated, seven years ago, he sat in this same seat due to an unfortunate circumstance: the passing of Mayor Art Ondish. This was now his seventh Reorganization Meeting as Mayor of Mount Arlington Borough. It was hard to believe how fast the time had flown by. At that first Reorganization Meeting seven years ago, Mayor Stanzilis challenged the Borough Council to a "race to the bottom" through "smart growth," meaning they were racing to the bottom of the tax rate in Morris County, if not the Greater New Jersey area, in order to give money back to Borough

residents. Since then, everyone had worked extremely hard as a team to help deliver on this challenge. He thanked the entire Borough Council, Administrator and CFO Ms. Rinaldi, staff and professionals for making everything possible. He thanked his wife, Laura, for her unending support and patience. Mayor Stanzilis then reported on the many accomplishments in 2022:

- A "Race to the Bottom" through "Smart Growth:"
 - o The Borough received over \$275,000 in grant awards towards various projects and equipment:
 - New Dial-a-Ride Bus
 - Bullet proof vests for the Police Department
 - McGregor Trail Design
 - DOT funding towards the Reba Road and Eric Lane road improvements
 - NJDEP grant to construct five rain gardens around the Borough including Borough Hall, Police Headquarters, Borough Library, MAPS and Decker schools
 - o Capital projects, utility and infrastructure improvements:
 - Windemere 1 water lines were installed.
 - There was an increase to the Borough's water threshold.
 - Water line installations were coming to McGregor Avenue, Floyd Drive, Hover Drive and the remainder of Windemere Avenue.
 - The Schmitz Terrace water tank was on schedule to get rehabbed this year.
 - The American Rescue Plan awarded Mount Arlington \$650,000 for the high-pressure booster station rehabilitation project. That was the amount the Borough had allocated for this project, so it appeared the project would be completely paid for.
 - Sewer installation for Hover Drive and Floyd Drive were moving along.
 - New Jersey Natural Gas was continuing to expand gas lines throughout town.
 - Getting public water and sewer to Lake Rogerene was a priority and would be coming sooner than later.
 - The Logan Way redevelopment project was completed successfully.
 - As part of a shared purchase with Wharton Borough, a new street sweeper was acquired over the summer. It immediately began helping to improve road cleanliness which resulted in less stormwater pollution into Lake Hopatcong.
 - Redevelopment Zones
 - Construction was expected to begin this year on The Orchards Village at 181 Howard Boulevard.
 - Shared Services
 - The Board of Education moved its offices into the DPW building, thus freeing up classroom space in the schools.
 - DPW Management shared service agreement with Wharton Borough
 - Animal Control shared service agreement with Hopatcong Borough as the lead agency; Wharton Borough; Byram Township; Stanhope Borough as well as Netcong Borough joining.
 - Health Department shared service agreement with Mount Olive Township.
 - Shared Court with Wharton Borough
 - Construction Official agreement with Jefferson Township
 - Morris County Joint Insurance Fund (JIF) with 45 other municipalities.
 Ms. Rinaldi was the current Chair of the Morris County JIF.
 - Fire and Police Dispatcher agreement
 - There were many successful Borough Recreation events in 2022:

- o The Mayor's Wellness Committee was offering Chair Yoga. It was finally back in the Library now that the COVID-19 pandemic was over.
- o Memorial Day Parade. Thanks to the Elks Lodge for hosting the Memorial Day Ceremony due to the rainy weather.
- o Summer Concert Series. Special thanks to Mark Rinaldi for his vision, talent and assistance in making the concerts such as huge success.
- Stormwater Management & Green Infrastructure Committee. This new committee may be the first Green Infrastructure Committee in a town of its small size in the entire State.
- Chief LaBruno would be retiring in 2023. This would be his last Reorganization meeting. The Police Department has thrived under his amazing leadership. He has accomplished so much, including leading the Police Department through the COVID-19 pandemic; mental health and domestic violence crises; and the rollout of the new body worn cameras. The quality of the Borough Police Department was a reflection of its leadership.
- The Fire Department would be coming back on January 17th for their swearing in. As a result of all the above accomplishments, the bottom line resulted in a decrease in the total Municipal tax rate. When he first became Mayor, the Municipal tax rate was 0.822. As of the end of 2022, the Municipal tax rate was 0.804, which was a decrease of 18 basis points in 7 years. This was all possible due to prudent fiscal management and a shared vision by the entire Borough Council, Administration, staff and professionals. God has blessed everyone in this room and brought them together for a reason. God Bless you all, and God Bless America.
