# BOROUGH OF MOUNT ARLINGTON COUNCIL MEETING MINUTES MARCH 7, 2023 7:00 PM

The Regular Meeting of the Borough Council of the Borough of Mount Arlington was held on Tuesday, March 7, 2023. This meeting was held in-person at the Municipal Building at 419 Howard Boulevard, Mount Arlington, New Jersey.

Mayor Stanzilis called the meeting to order at 6:59PM.

Mr. Bansch stated, "Adequate Notice of this meeting of the Mayor and Council of the Borough of Mount Arlington was given as required by the Open Public Meetings Act as follows: Notice was published in the Daily Record and the Roxbury Register on January 10, 2023 and posted on the bulletin board in the main hallway of the Borough Municipal Building on January 4, 2023; notice of this meeting is on file in the Office of the Borough Clerk. In accordance with the Open Public Meetings Act (N.J.S.A. 10:4-1 et seq.), the Borough Council opens every public meeting for comments of the public. However, in accordance with N.J.S.A. 10:4-12: 'Nothing in this Act shall be construed to limit the discretion of a public body to permit, prohibit or regulate the active participation at any meeting.' Speakers at Borough meetings shall have five minutes to present their comments to the Borough Council so as not to consume time that would otherwise be allotted to other persons who wish to speak."

The Mayor led everyone in the Pledge of Allegiance. He then asked everyone to remain standing to observe a moment of silence to pray for all Police Officers serving throughout the great state of New Jersey and the United States of America.

Ms. Eckert announced Decker School launched a new student initiative called Decker Day. It would be held at the end of each marking period. It was a school-wide community-building program designed to allow students and faculty to unite as a school, celebrate each other's achievements, promote school spirit, and honor positive character traits in the students. #### Mayor's Report

Mayor Stanzilis reported last weekend was the 13<sup>th</sup> Annual Leap in the Lake event sponsored by the Lake Hopatcong Elks. People came from all over to participate and had a great time. The event was a huge success, having raised \$117,000 for children with special needs. The Borough was blessed to have the Elks in town. The Borough had a meeting with Altice (Optimum) to follow up on upgrades that were promised to the Borough two years ago. They were currently waiting to hear back from Altice regarding when the new fiber-optic lines would be connected. Chief LaBruno's Retirement

Walkout ceremony was great; it was an honor to be there. He attended a presentation at the New York Jets Training Center on drug addiction with an emphasis on the fentanyl crisis in America. Lastly, the Mayor attended a presentation on digital equity in America, which included information on BEAD and DE Planning Programs, as well as using libraries as a powerful resource to help close the digital divide.

## **Borough Administrator's Report**

Ms. Rinaldi reported she had spoken earlier with Ms. Lyons and there were a few updates from the Lake Hopatcong Commission which overlapped with the Borough:

- Resolution 2023-59 was to authorize the execution between the Borough and the Lake Hopatcong Commission for transfer of ownership of the aeration system at the beach.
- She and Ms. Lyons were on a preliminary call with the DEP earlier today regarding grant awards which the Borough and LHC received for raingardens to be constructed on Borough properties, Decker School and MAPS. More information to come.
- Ms. Lyons was looking to get a schedule together for three small scale watershed projects to be implemented in the spring including plantings along the banks of Memorial Pond. She would follow up at next month's Council meeting.

The Municipal Budget would be introduced at the April Council Meeting.

There were two add-on resolutions to tonight's agenda:

- Resolution 2023-61 Transfer of Funds
- Resolution 2023-62 Supporting Participation in Borough of Hopatcong LEAP Implementation Grant for Animal Control and Shelter Shared Services.

Lastly, Ms. Rinaldi announced the Annual Easter Egg Hunt and Pictures with the Easter Bunny would be held at Fireman's Field on March 18<sup>th</sup> at 10:00am.

#### Police Chief's Report - None

Mayor Stanzilis thanked the Fire Department for their help earlier today with a house fire at 24 Bertrand Island Road.

#### Fire Chief's Report

Assistant Fire Chief D'Arco reported there was a serious house fire today at 24 Bertrand Island Road. Thankfully there were no injuries. Of the 4 people who inhabited the home, 3 self-relocated and 1 person was relocated by the Red Cross. For the month of February, the Fire Department had 17 total incidents totaling 117.49 man-hours. On February 6<sup>th</sup> they did Fire Prevention at Decker School; the kids really enjoyed it. In February, the Fire Department sent a mutual aid tender to Hudson County for the City of Hoboken. It was a County-wide tender due to a ruptured water main break in Hoboken.

#### **Council Committee Reports**

Councilwoman Galate

Councilwoman Galate reported the Fire Department continued honoring a "Firefighter of the Week." She read bios for those recognized most recently: Firefighter James Siuzdak; Firefighter Anthony Gonzales; Firefighter Ulysses Rodriguez; and Firefighter Matthew Deslonde.

#### Councilman BaRoss

Councilman BaRoss had nothing new to report.

#### Councilwoman Fostle

Councilwoman Fostle reported the 2023 Municipal Budget would be introduced next month. She would be doing the budget presentation at the next Council Meeting on April 4<sup>th</sup>. She had a tentative meeting scheduled for the end of the month with landscape architect John Roberts to discuss a proposal for Memorial Park, the Municipal Beach and Borough parks in general.

## Councilman Cangiano

Councilman Cangiano reported he received an email from the Musconetcong Sewerage Authority asking member towns to share a flyer with residents about the dos and don'ts of what to dump down the drain or flush down the toilet. The flyer addressed common causes of pipe and sewer backups including fats and greases, baby diapers and disposable baby wipes.

## Council President Delaney

Council President Delaney stated there were two big events for Police Departments: when a Chief retired and when a new Chief was sworn in. Tonight's swearing in was spectacular. It was great to see so much respect and support from the Borough Police Officers, County dignitaries and many police chiefs from other towns who attended.

#### **Public Comment**

Janet Vignola, 66 Ridgeview Lane – Ms. Vignola stated she was representing the Mount Arlington Borough Democrats. A couple of months ago, while at a Borough Council meeting, she heard Ms. Eckert's Board of Education report and request for volunteer readers for Education Week. Ms. Vignola was happy to report she had recruited four people to be readers at the Decker School. She was very impressed with the school; it was a warm and friendly atmosphere. Regarding the Mount Arlington Democrats, most of their meetings had been held on Zoom due to the COVID-19 pandemic, Now that the pandemic was over, they were looking for places to meet in-person. They were wondering if the Borough would consider allowing them to use Borough-owned property to conduct their meetings.

Mr. Jessup replied government property could not be used for partisan political activities.
