BOROUGH OF MOUNT ARLINGTON COUNCIL MEETING MINUTES JUNE 7, 2023 7:00 PM

The Regular Meeting of the Borough Council of the Borough of Mount Arlington was held on Wednesday, June 7, 2023. This meeting was held in-person at the Municipal Building at 419 Howard Boulevard, Mount Arlington, New Jersey.

Mayor Stanzilis called the meeting to order at 7:02PM.

Mr. Bansch stated, "Adequate Notice of this meeting of the Mayor and Council of the Borough of Mount Arlington was given as required by the Open Public Meetings Act as follows: Notice was published in the Daily Record and the Roxbury Register on January 10, 2023 and posted on the bulletin board in the main hallway of the Borough Municipal Building on January 4, 2023; notice of this meeting is on file in the Office of the Borough Clerk. In accordance with the Open Public Meetings Act (N.J.S.A. 10:4-1 et seq.), the Borough Council opens every public meeting for comments of the public. However, in accordance with N.J.S.A. 10:4-12: 'Nothing in this Act shall be construed to limit the discretion of a public body to permit, prohibit or regulate the active participation at any meeting.' Speakers at Borough meetings shall have five minutes to present their comments to the Borough Council so as not to consume time that would otherwise be allotted to other persons who wish to speak."

The Mayor led everyone in the Pledge of Allegiance. He then asked everyone to remain standing to observe a moment of silence to pray for the safety of all firefighters in the nation.

Mayor's Report

Mayor Stanzilis reported the Memorial Day Parade was a great event with great weather. He thanked Ms. Todd and Ms. Rinaldi for coordinating the event. The Lake Hopatcong Foundation Block Party also went well despite the rainy weather. The recent meeting at town hall with residents from McGregor Avenue went very well. McGregor Avenue will have water line installation completed, as well as drainage, milling and paving of the entire road. These improvements will help the water quality of Lake Hopatcong. In addition to the town hall meeting, there were also three nights of walking McGregor Avenue, in different sections, to understand each individual resident's specific needs.

Borough Administrator's Report

Ms. Rinaldi reported the next Summer Concert Series event was Saturday, June 17th from 3-5pm at Memorial Beach. Friday, June 30th was the Fourth of July Fireworks. Beach Yoga was starting up again for the summer season and would run weekly on Sundays from June 18th through August 27th from 9-10am. There was a \$10 fee to attend. Residents were encouraged to sign up and pay for Beach

Yoga online on Community Pass. She thanked everyone who volunteered to join her at the Lake Hopatcong Block Party. It was truly a team effort.

Police Chief's Report

Chief Green reported Police Department personnel attended various trainings including CPR training; Breach Point; Search and Rescue, Rifle Qualification; and Advanced Leadership.

Fire Chief's Report

Chief Lima reported, for the month of May, there were 8 calls totaling 27.21 man-hours. Tonight, they were awarding a scholarship to Roxbury High School senior Katarina Guerra. The Fire House got rid of Active 911 and was moving over to Rover which was paid for by the County. He asked everyone to please keep Firefighter Bizarro in their prayers. The Mount Arlington Fire Department Officers recently visited Mr. Bizarro at the hospital and presented him with the Chief William Chaplin Valor Award for saving a life back in 1978.

Council Committee Reports

Councilman BaRoss

Councilman BaRoss reported Construction Official Tom Mahoney would be retiring July 1st. To take his place was the new Jefferson Township Construction Official, Domenick Carnevale. The recent Summer Concert Series event was a big success. The free ice cream was a nice touch. He enjoyed walking in his first Mount Arlington Memorial Day Parade. He thanked everyone who came out.

Councilwoman Fostle

Councilwoman Fostle reported she had been working on a Mount Arlington Park Master Plan. The intent was to create a plan and vision for improvements to Memorial Park and Beach. The plan may include cleaning up the hiking trails; offering residents more connectivity between the Municipal Beach and Memorial Park; adding bathrooms; a boardwalk and more lighting. This would be accomplished while keeping with the aesthetics ordinance of the Borough to maintain its historical lakeside resort character.

Councilwoman Galate

Councilwoman Galate reported the Fire Department continued honoring a "Firefighter of the Week." She read bios for those recognized most recently: First Lieutenant Wes Martin; and Firefighter Jonathan Feinberg. The Fire Department's 100th Anniversary was July 29th at 11am; rain date of August 12th. She encouraged everyone to check out all that was going on at the Borough Library. There was a lot going on for the residents.

Council President Delaney

Council President Delaney reported the Memorial Parade was a huge success. The Fire Department's 100th Anniversary was coming up soon and he was looking forward to it. He thanked everyone who came out to vote in the Primary Election.

Mayor Stanzilis congratulated Council President Delaney, Councilwoman Fostle and Councilman BaRoss on their Primary Election wins.

Public Comment

Dennis Keenan, 5 Kadel Drive – Mr. Keenan spoke as a member of the Mount Arlington Knolls Property Owners Association (MAKPOA) who resides in the Knolls section of Mount Arlington. He, along with several other Knolls residents, were at the meeting to express their frustrations over the closing of Knolls Beach, which was located at the end of Hillard Drive. He stated the entrance to Knolls Beach had recently been locked, and the beach closed indefinitely, by the current property owner. Mr. Keenan explained the Knolls section of Mount Arlington, which included Knolls Beach, was under a 99-year lease since Henry Kadel purchased the land from Mount Arlington in 1961. Mr. Keenan passed out copies of the original Deed of Sale for the Mayor and Council to review. He wished to make the Borough aware of the obligations included in the original Deed of Sale. He referenced a specific condition on the Deed which he believed meant any property subdivided out of that purchase agreement would have the legal right to use Knolls Beach. He respectfully asked that the Borough Attorney be authorized to investigate the matter further to determine if the municipal obligations were being violated. He also wanted to make sure the Borough Zoning Officer, Borough Engineer and Land Use Board were made aware of the situation. Mr. Keenan clarified the Borough was mentioned only in the Deed of Sale; not in the 99-year lease.

Mayor Stanzilis replied he would instruct the Borough Attorney to review the Deed of Sale to see if the Borough had any legal grounds to get involved or if it was strictly a matter between two private entities. There were no objections by the Council.
